1. ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Consolidation

In the opinion of the director, the company and its subsidiary undertakings comprise a small group. The company has therefore taken advantage of the exemption provided by Section 398 of the Companies Act 2006 not to prepare group accounts.

Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

Going concern

The accounts have been prepared on a going concern basis notwithstanding that there is an overall capital deficiency of £4166 including a working capital deficiency of £2,170. This deficiency includes amounts owing to a group company totalling £2,649. This balance would only be withdrawn at levels not likely to prejudice the company's ability to continue trading.
