Our aim is to gather information from Parent Carers and using these unique shared experiences, we take part in consultations and participation work with Education, Social Care and Health which helps us to shape the development and delivery of services to children in Cornwall who have an additional need/disability. We also pass on information to families via a newsletter enabling parent carers to gain greater knowledge and understanding of the services available from health, education, local authority, and the voluntary sector.

We arrange events for parents to attend to ensure they are signposted to the correct services and allows them to meet other carers. This supports carers to feel less isolated and supports their own well-being. This has benefitted many parent carers in Cornwall.

Without the voice of our organisation in participation, services would be very different for families, through our work families in our community benefit through services being fit for purpose.

The work we do has been reflected in Peer-to-Peer reports delivered to our Local Authority and it was recognised we were a strength to the area of Cornwall for the way we support our community.

We were recognised in a recent Ofsted report for the impact we had in working in partnership with services to ensure the voices of families was heard.

We regularly send out surveys to stakeholders to gather their views on how we as an organisation supporting our community is working.

We also hold face to face consultation meetings to gather the views of stakeholders. The main feedback has been to meet with hidden families who are in more isolated areas of our county, this we have done by identifying which areas we needed to work in more and hold face to face meetings with stakeholders in more isolated areas.

We have also linked in more working with schools, preschools, and a wider network to ensure we reach families to gain their views from a younger age group.
