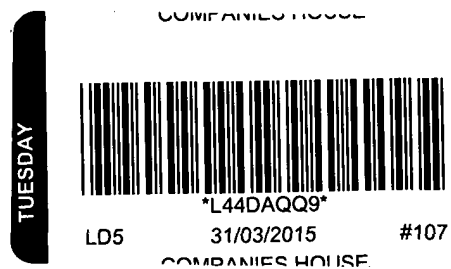

1. ACCOUNTING POLICIES
