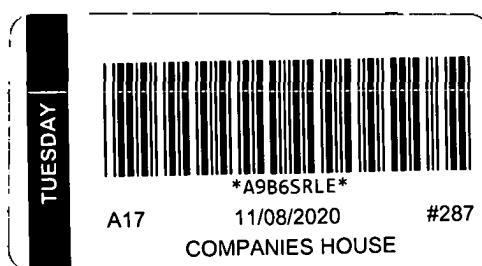
IT IS ORDERED THAT Dack Motor Grp. Ltd (08161349) be wound up by this Court under the provisions of the Insolvency Act 1986
