ORDER

UPON the Application of the Applicant sealed on 23 November 2022

AND UPON the Court reading the First Witness Statement of Nicholas Stephen Joseph Parsk

AND UPON the Court considering that the Order can be made without the need for a hearing

AND UPON notice of the Application having been given to the Secretary of State

IT IS ORDERED THAT:

1. Nicholas Stephen Joseph Parsk (**Outgoing Officeholder**) be removed from office in respect of each of the cases listed in the Schedules attached to this Order (**Block Transfer Cases**) from the date of the Order pursuant to Rule 12.37(2) of the Insolvency (England and Wales) Rules 2016 (**Rules**) without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Insolvency Act 1986 (as amended) (**the Act**) or the Rules for the Block Transfer Cases; or (ii) file a receipts and payments account.
2. Joann Louise Leach, Francis Florian Amadeus Wessely, Tauseef Ahmed Rashid, David Patrick Meany, Brian Francis Burke and Chris Newell (**Replacement Officeholders**) be appointed as joint Replacement Officeholders as set out in the Schedules to this Order in respect of each of the Block Transfer Cases from the date of the Order pursuant to Rule 12.37(3) of the Rules without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the Block Transfer Cases; or (ii) file a receipts and payments account.
3. In each of the Block Transfer Cases, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
4. The creditors and in the case of members' voluntary liquidations, the members, in each of the Block Transfer Cases be notified of this Order solely by way of one composite advertisement published in the London Gazette

(**Advertisement**) within 21 days of receipt of the sealed Order from the Court.

5. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies and persons listed in the Schedules who has an objection to this Order shall have 21 days from the date of the Advertisement to apply to court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the Block Transfer Cases until further or other Order by the court.
6. The Replacement Officeholders shall give notice to the Secretary of State and, in the case of companies, the Registrar of Companies in respect of the insolvency proceedings listed in the Schedules of the terms of terms of this Order as soon as is reasonably practicable following this Order being made.
7. The Outgoing Officeholder shall file a copy of this Order with each of the courts listed in the Schedules where applicable.
8. Nothing in this Order shall release the Outgoing Officeholder from any obligation to give and file notices at Companies House in respect of their removal under this Order in respect of the Block Transfer Cases.
9. In respect of the administrations within the Block Transfer Cases the Outgoing Officeholder shall receive his discharge from liability under paragraph 98 of Schedule B1 to the Act 28 days after the Advertisement subject always to further order of the Court in the event that any application is made under paragraph 5 above. In respect of the other categories of Block Transfer Cases the Outgoing Officeholder shall receive his discharge or release upon application to the Secretary of State or in accordance with the terms of the voluntary arrangements, as appropriate.
10. Pursuant to rules 18.6, 18.7 and 18.8 of the Rules, in respect of each of the Block Transfer cases, the time by which progress reports are required to be delivered by an office-holder of the Block Transfer Cases shall be unaffected and the next routine report due to creditors shall contain reference to an explanation of the effect of this Order.

11. The terms of this Order shall not apply to any case which is listed in the Block Transfer Cases but which, prior to this Order being sealed by the Court, is concluded and the case closed (in which case for the avoidance of doubt the appointment of the relevant Replacement Officeholder shall not take effect).
12. The costs of this Application (including VAT) shall be met by Quantuma Advisory Limited.
13. Nothing contained in Paragraph 12 shall prejudice the Respondents from charging to each case listed in the Schedules the cost of obtaining an insolvency practitioner's security bond in respect of those cases.
