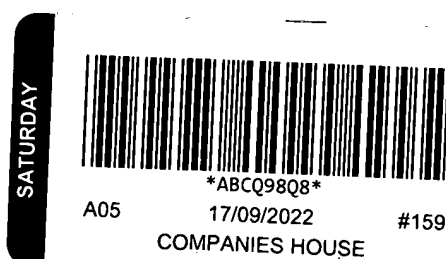

Neighbourworks CIC is a business that supports people to learn new skills, make new friends and contribute to their community through traditional wool crafts. We run three projects; 1. The Knit Stop, 2. The Knit Stop for Kids and 3. Wool on the Exe, our retail community fibre arts space. Unfortunately, due to the pandemic, the shop was closed from January to April. However, we continued to support our weekly Zoom group with 8-10 people joining in each week. We resumed our Knit Stop for adult programme in September and our weekly drop in group at the shop at the same time. We also resumed our Knit Stop for Kids programme in 3 local schools. These social knitting/crafting sessions offer a time to be creative and connect with others which in turn improves overall well-being. In addition, we launched the Warm People Project in partnership with the Exeter Food Bank and St Petrocks. We encouraged the donation of yarn and the knitting/crocheting of blankets and garments to go to each of these charities. In all, over 100 items were made and donated. We also continued to support Knit for Peace through our volunteer Fix Your Stitch programme. £170 was raised and our volunteer was able to support 34 individuals with their projects. We also partnered with the Flow Project to plant a wool dyeing garden across the street from the shop. Volunteers raised the plants at home and came out to weed and plant them in a covid safe environment. Work continued on the grant funded Knit Stop for Kids project to explore a theory of change when teaching children to knit in a school setting. This was hampered by the pandemic but is now complete. We also supported a crochet-a-long in the Autumn and this was enthusiastically embraced by many.
