

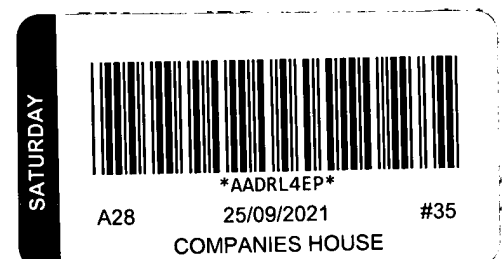



PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

Neighbourworks is a business that supports people to learn new skills, make new friends and contribute to their community through traditional fibre crafts. Our social projects are The Knit Stop, The Knit Stop for Kids, and Wool on the Exe, our retail community fibre arts space. It goes without saying that 2020 was a challenging year. All of our community projects involve people meeting in groups which was not possible at all. So we improvised the best we could. Firstly we moved our in-store social drop-in group to a Friday afternoon Zoom session. This has become so popular that we have kept it going even though the shop is open. We found that many participants were home-bound and loved joining the group via Zoom. These are people we would not have reached in ordinary times. We developed a community project in late 2020 with over a hundred people participating to knit or crochet squares to make a large tree for the shop window. The response was such that we were able to make 3 trees.. There is an online blog post here <https://www.woolonthexe.com/blogs/news/a> about it. The trees were then made into baby blankets and donated to a local hospital. Another project involved working with the Flow project in Exeter to establish a garden across the street from the shop to grow plants for dyeing wool. 6-8 community members helped with the weeding and planting. The plan is to offer outdoor workshops and information boards to the community in the future. Whilst the shop was closed to the public, we continued to trade online offering a daily posting and collection service. Often the conversations at the door were the only contact some people had in their day. We also offered video support via WhatsApp and Facebook video. And because we continued to trade, we were able to support local independent yarn dyers and other small businesses. We published our first book which was developed entirely by local people. Proceeds of the sale of the book went to supporting our social projects as well as the charity Knit for Peace. Lastly, we hosted a knit-a-long project that encouraged people to join in knitting a specific scarf pattern and to share their projects via social media. It was widely supported and appreciated.
