THIS DEED is dated 4 October 2019 and is made **BETWEEN:**

- (1) **THE ENTITIES NAMED IN SCHEDULE 1 AS CHARGORS** (each a **Chargor**); and
- (2) **FONDS RUSNANO CAPITAL S.A.** (the **Lender**).

BACKGROUND:

- (A) Pursuant to a debenture dated 25 June 2015 between each Chargor (other than PBB Devices Limited) and Knight Therapeutics Inc. (the **Original Lender**) (the **First Original Security Agreement**), the Chargors (other than PBB Devices Limited) created Security Interests over certain of its assets as security for, among other things, the present and future obligations and liabilities of Ascension Healthcare plc (formerly known as Pro Bono Bio plc) (the **Borrower**) under the Loan Documents (as amended or supplemented).
- (B) Pursuant to a debenture dated 11 May 2016 between PBB Devices Limited and the Original Lender (the **Second Original Security Agreement**), PBB Devices Limited created Security Interests over certain of its assets as security for, among other things, the present and future obligations and liabilities of the Borrower under the Loan Documents (as amended or supplemented).
- (C) Pursuant to a debenture dated 26 March 2019 between Ascension Healthcare Development Limited and Fonds Rusnano Capital S.A. (the **Third Original Security Agreement**, and together with the First Original Security Agreement and the Second Original Security Agreement, the **Original Security Agreements**), Ascension Healthcare Development Limited created Security Interests over certain of its assets as security for, among other things, the present and future obligations and liabilities of the Borrower under the Loan Documents (as amended or supplemented).
- (D) The rights of the Original Lender in respect of the Original Security Agreements and the US\$15,000,000 Loan Agreement dated 25 June 2015 (the **Loan Agreement**) between the Borrower and Original Lender, as amended by amendment letter on 5 October 2015, were assigned to the Lender and simultaneously amended pursuant to an assignment and amendment agreement dated 27 March 2017 between, among others, the Chargors, the Original Lender and the Lender (the **Assignment and Amendment Agreement**) and varied by the supplemental agreements dated 11 May 2017 (the **First Supplemental Agreement**), the supplemental agreement dated 22 September 2017 (the **Second Supplemental Agreement**), the supplemental agreement dated 21 December 2017 (the **Third Supplemental Agreement**) and the supplemental agreement dated 26 March 2019 (the **Fourth Supplemental Agreement**) and amendment letters dated 30 June 2017,, on or about May 2018, and 12 December 2018 (the **Amendment Letters**).
- (E) The Loan Agreement has been or is to be further amended pursuant to a supplemental agreement dated on or about the date of this Deed between, amongst others, the Chargors and the Lender (the **Fifth Supplemental Agreement**).
- (F) The Chargors and the Lender consider that the Security Interests created by the Chargors under the Original Security Agreements secure payment of the Secured Liabilities (as defined below), but enter into this Deed in case they do not.
- (G) This Deed is supplemental to each Original Security Agreement.
- (H) It is intended that this document takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

IT IS AGREED as follows:

1. INTERPRETATION

- (a) In this Deed:

Assigned Documents means the documents set out in Schedule 3 (Assigned Documents).

Intellectual Property means all intellectual property, including patents, utility models, trade and service marks, trade names, domain names, right in designs, copyrights, moral rights, topography rights, rights in databases, trade secrets and know-how, in all cases whether or not registered or registrable and including registrations and applications for registration of any of these and rights to apply for the same and all rights and forms of protection of a similar nature or having equivalent or similar effect to any of these anywhere in the world (including the trade marks, patents, patent applications and rights listed in Schedule 2 (Intellectual Property) and, in relation to a Chargor, "its Intellectual Property" means all Intellectual Property in which it has any rights (including any listed in Schedule 2 (Intellectual Property)).

Loan Document has the meaning given to it in the Loan Agreement and, for the avoidance of doubt, any reference to the Loan Agreement or any Loan Document includes the Loan Agreement as amended from time to time (including without limitation pursuant to the Assignment and Amendment Agreement and each Supplemental Agreement).

Secured Liabilities means all monies from time to time due or owing, and all obligations and other actual or contingent liabilities from time to time incurred, by the Borrower to the Lender under the Loan Documents:

- (a) in whatever currency; and
- (b) whether due, owing or incurred alone or jointly with others or as principal, surety or otherwise.

Security Interests means a mortgage, charge, pledge, lien or other security interest securing any obligation of any person or any other agreement or arrangement having a similar effect.

Supplemental Agreement means the First Supplemental Agreement, the Second Supplemental Agreement, the Third Supplemental Agreement, the Fourth Supplemental Agreement or the Fifth Supplemental Agreement.

- (b) Capitalised terms defined in the First Original Security Agreement have, unless expressly defined in this Deed, the same meaning in this Deed.
- (c) The provisions of clause 1.3 (Construction) of the First Original Security Agreement apply to this Deed as though they were set out in full in this Deed except that references to the First Original Security Agreement will be construed as references to this Deed.
- (d) Any reference in this Deed to any share, stock, debenture, bond or other security or investment includes:
 - (i) any dividend, interest or other distribution paid or payable; and
 - (ii) any right, money or property accruing or offered at any time by way of redemption, substitution, exchange, bonus or preference, under option rights or otherwise;

in each case, in relation to that share, stock, debenture, bond or other security or investment;

- (e) Any covenant of the Chargors under this Deed (other than a payment obligation) remains in force until the date on which:
 - (i) all of the Secured Liabilities have been unconditionally and irrevocably paid or discharged in full; and
 - (ii) the Lender has ceased to have any commitment, obligation or other liability (whether actual or contingent) to make any credit or provide any other accommodation to the Borrower under any Loan Document.
- (f) The terms of the other Loan Documents and of any side letters between any Parties in relation to any Loan Document are incorporated in this Deed to the extent required to ensure that any purported disposition of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.
- (g) If the Lender (acting reasonably and in good faith) determines that an amount paid to it under a Loan Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount will not be considered to have been irrevocably paid for the purposes of this Deed.
- (h) Unless the context otherwise requires, a reference to a **Secured Asset** includes the proceeds of any disposal of that Secured Asset.

1.2 Third party rights

- (a) Unless expressly provided to the contrary in this Deed, a person who is not a party to this Deed has no right under the Third Parties Act to enforce or to enjoy the benefit of any term of this Deed.
- (b) Notwithstanding any term of this Deed, the consent of any person who is not a party to this Deed is not required to rescind or vary this Deed at any time.
- (c) Any Secured Party that is not a Party may enforce and enjoy the benefit of any Clause which expressly confers rights on it, subject to paragraph (b) above and the provisions of the Third Parties Act.

2. CREATION OF SECURITY

2.1 General

- (a) All the security created under this Deed:
 - (i) is created in favour of the Lender;
 - (ii) is created over present and future assets of each Chargor;
 - (iii) is security for the payment and satisfaction of all the Secured Liabilities; and
 - (iv) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994.
- (b) All the security created under this Deed:
 - (i) is created in case the security created by the Original Security Agreements does not secure all of the Secured Liabilities; and

- (ii) is created in addition to and does not affect the security created by the Original Security Agreements.
- (c) Where this Deed purports to create a first fixed Security Interest, that Security Interest will be a second ranking Security Interest ranking subject to the equivalent Security Interest created by an Original Security Agreement until such time as the Security Interest created by that Original Security Agreement ceases to have effect.
- (d) Where a right or asset has been assigned (subject to a proviso for re-assignment on redemption) under an Original Security Agreement and the same asset or right is purported to be assigned (subject to a proviso for re-assignment on redemption) again under this Deed, that second assignment will take effect as a fixed charge over that right or asset and will only take effect as an assignment if the relevant Security Interest created by that Original Security Agreement ceases to have effect at a time when this Deed still has effect.

2.2 Fixed charges

Subject to Clause 4 (Non-Assignable Rights), as continuing security for the payment and discharge of the Secured Liabilities, each Chargor with full title guarantee charges to the Lender by way of first fixed charge (which so far as it relates to land in England and Wales vested in any Chargor as at the date of this Deed will be a charge by way of first legal mortgage and so far as it relates to other land shall take effect as an equitable mortgage):

- (a) **Land:** all of its rights as at the date of this Deed in all of its rights in any land (together the **Mortgaged Properties**) in each case together with all of its rights in all buildings, structures, erections, fixtures and fittings (including trade fixtures and fittings) from time to time on any of the Mortgaged Properties and any proceeds of disposal of any of the Mortgaged Properties;
- (b) **Chattels:** all of its rights in any plant, machinery, vehicles, equipment and other chattels (but excluding its stock in trade or work in progress);
- (c) **Goodwill:** any goodwill and uncalled capital from time to time and all of its rights to future calls in respect of capital;
- (d) **Bank accounts:** all of its rights in any credit balances on any bank accounts and the indebtedness represented by them;
- (e) **Other Debts:** all of its rights in its Debts;
- (f) **Shares and other Investments:** all of its rights in its Investments including in any uncalled capital;
- (g) **Intellectual property rights:** all of its rights in its Intellectual Property; and
- (h) **Licences:** all licences, consents and other Authorisations held in connection with its business or the use of any Secured Assets and all of its rights in connection with them.

2.3 Assignments

Subject to Clause 4 (Non-Assignable Rights), as security for the payment and discharge of the Secured Liabilities, each Chargor with full title guarantee assigns absolutely to the Lender:

- (a) **Insurance:** all of its rights in its Insurances, including those relating to the Mortgaged Properties, and in any Insurance Proceeds; and
- (b) **Assigned Documents:** all of its rights under the Assigned Documents.

For the avoidance of doubt, each Chargor will remain at all times liable in respect of all of its obligations under each of the Assigned Documents to the same extent as if this Security had not been created and neither the Lender nor any Receiver will be under any obligation or liability to any Chargor or to any other person under or in respect of any Assigned Document.

2.4 Floating charge

As security for the payment and discharge of the Secured Liabilities, each Chargor with full title guarantee charges to the Lender by way of first floating charge the whole of its undertaking and other assets (other than assets validly and effectively charged or assigned (whether at law or in equity) from time to time pursuant to Clauses 2.2 and 2.3 by way of fixed security and, in the case of PBB (Malta) Limited only, other than the Excluded Shares). Schedule B1, Paragraph 14 IA shall apply to the floating charge contained in this Deed.

2.5 Trust

If or to the extent that the assignment or charging of any Secured Asset is ineffective because of a prohibition on that assignment or charging, the Chargor holds it on trust for the Lender to the extent doing so would not breach any provision or term contained in the relevant Secured Asset.

3. CRYSTALLISATION OF FLOATING CHARGE

3.1 Crystallisation by notice

The Lender may at any time by notice in writing to a Chargor convert the floating charge created by that Chargor in Clause 2.4 (Floating charge) into a fixed charge with immediate effect as regards any Secured Asset specified in the notice if:

- (a) an Event of Default has occurred and is continuing; or
- (b) the Lender considers (acting reasonably) that any Secured Asset is in danger of being seized or sold pursuant to any form of legal process or otherwise in jeopardy.

3.2 Automatic crystallisation

The floating charge created by a Chargor in Clause 2.4 (Floating charge) shall automatically (without notice to that Chargor) be converted into a fixed charge with immediate effect as regards all assets subject to the floating charge if:

- (a) that Chargor creates a Lien other than a Permitted Lien over any Secured Asset or attempts to do so or any Secured Asset is disposed of contrary to the provisions of the Loan Documents or is otherwise in jeopardy;
- (b) any person levies or attempts to levy any distress, execution, sequestration or other process against any Secured Asset;
- (c) the Lender receives notice of a proposal or intention to wind up, or appoint an administrator of, that Chargor or if that Chargor is wound up or has an administrator appointed; or

- (d) on the crystallisation of any other floating charge over the Secured Assets.

Nothing in this Clause 3 shall affect the crystallisation of the floating charge created by any Chargor under applicable law and regulation.

4. NON-ASSIGNABLE RIGHTS

If the rights of a Chargor under a document or to any other asset cannot be secured in the manner contemplated by this Deed without the consent of a party to that document, or a Chargor purports to charge or assign an asset under this Deed and such charge or assignment breaches a term of any agreement binding on such party in respect of that asset because the consent of a person has not been obtained:

- (a) subject to (c) below, the security created pursuant to this Deed will secure all amounts which such party may receive, or has received, under that document or other asset but exclude the document or other asset itself, and the relevant charge or assignment will (to the extent no breach of the relevant agreement would occur) secure the rights in respect of that document or other asset but shall exclude the asset itself;
- (b) unless the Lender otherwise requires, the relevant Chargor must use reasonable endeavours to obtain the consent of the relevant party and once obtained, shall, as soon as reasonably practicable, provide a copy of such consent to the Lender; and
- (c) upon receipt of the relevant consent, the relevant document and/or other asset shall become subject to this Deed in favour of the Lender under the relevant provision of Clause 2 (Creation of Security).

5. INCORPORATION

The provisions of clause 5 (Perfection of security and further assurance) to 28 (Counterparts) (inclusive) of the First Original Security Agreement are deemed to be incorporated into this Deed with all necessary modifications as if they were set out in full in this Deed provided however that no Chargor shall be obliged to procure the delivery of share certificates or other documents of title to or representing its Investments referred to in clause 9.1 (Delivery of Mortgage Property Title) or clause 10.1 (Delivery of Investment title documents; registration) of the First Original Security Agreement which are in the possession of Knight Therapeutics Inc. (or otherwise not in the control or possession of the Chargors provided that the Chargors must use all reasonable endeavours (which shall not however include an obligation to pay money) to procure the delivery of share certificates or other documents of title to the Lender).

6. H.M. LAND REGISTRY

The Chargor consents to a restriction in the following terms being entered into on the Register of Title relating to any Mortgaged Property registered at H.M. Land Registry:

"No disposition of the registered estate by the proprietor of the registered estate is to be registered without a written consent signed by the proprietor for the time being of the charge dated [] in favour of [] referred to in the charges register or their conveyancer. (Standard Form P)"

7. MISCELLANEOUS

- (a) The Original Security Agreement will remain in full force and effect.
- (b) This Deed is designated a Loan Document.

8. GOVERNING LAW

This Deed is governed by, and shall be construed in accordance with, English law.

9. ENFORCEMENT

9.1 Jurisdiction of English courts

- (a) The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute regarding the existence, validity or termination of this Deed) (a **Dispute**).
- (b) The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.

9.2 Service of process

- (a) Without prejudice to any other mode of service allowed under any relevant law, each Chargor (other than any Chargor incorporated in England and Wales):
 - (i) irrevocably appoints Ascension Healthcare plc as its agent for service of process in relation to any proceedings before the English courts in connection with this Deed; and
 - (ii) agrees that a failure by the process agent to notify it of the process will not invalidate the proceedings concerned.
- (b) If the appointment by any Chargor of the person mentioned in sub-paragraph (a)(i) above ceases to be effective, it shall immediately appoint another person in England as its agent for service of process in relation to any proceeding before the English courts in connection with this Deed. If it fails to do so (and that failure continues for a period of not less than 15 Business Days), the Lender shall be entitled to appoint such a person by notice to the relevant Chargor.

THIS DEED has been entered into as a deed on the date stated at the beginning of this Deed.
