- The Replacement Office-holder be appointed as joint replacement office-holder with Andrew McTear and Nicholas Barnett in the case of Chalfcroft Limited (in creditors' voluntary liquidation) referred to in Part 3 of Schedule A from the date of this order.
- 5. The creditors in each of the Block Transfer Cases be notified of this order by advertisement published in the London Gazette within 28 days of the date of this order.
- 6. Any creditor or in the case of any members' voluntary liquidation, any member in respect of any of the estates listed in Schedule A to this order who has an objection to this Order do have permission to apply to the Court on notice to the Applicants, within 56 days of the advertisement referred to in paragraph 5 of this Order for the purposes of applying to vary or discharge the Order in so far as it affects the estate or estates of which they are a creditor. Such application shall not affect the transfer of the Block Transfer Cases listed in Schedule A until further order of the Court
- 7.
