1a. Basis Of Accounting

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with FRS102 - The Financial Reporting Standard applicable in the UK and Republic of Ireland and the Companies Act 2006.

1b. Going Concern

Shortly after the year end the company secured significant funding from existing and a new investor. This new finance will be used to further the company's activities and future growth strategy, this together with the support of the other stakeholders should ensure that the company will continue for the foreseeable future and as such these accounts have been prepared on a going concern basis.

1c. Investments

Fixed asset investments in subsidiaries are shown at cost less amounts written off.
