# Year ended 30 September 2021

### 1. General information

The company is a private company limited by shares, registered in England. The address of the registered office is Midway House, Herrick Way, Staverton Technology Park, Cheltenham, Glos, GL51 6TQ, England.

#### 2. Statement of compliance
