#### Guarantees and other financial commitments

Creditors include a secured bank loan of £Nil (2018: £3,211). The fixed rate interest on the loan is 5.09% per annum and the loan is repayable in less than five years. The security comprises a fixed and floating charge over all the property of the company. In addition it also contains a negative pledge.

The company operates a defined contribution pension scheme. The assets of the scheme are held separately from those of the company in an independently administered fund. Amounts payable to the scheme at the end of the year amounted to £3,969 (2018: £3,412).

At 30 November the company had future minimum lease payments under non-cancellable operating leases of £410 (2018: £410).
