1 INTRODUCTION

The following details the progress of the winding up in the period from 24 June 2018 to 23 June 2019.

2 RECEIPTS & PAYMENTS

An Abstract of my receipts and payments for the period 24 June 2018 to 23 June 2019 is attached. Gross Bank Interest of £47.91 was received during the period of this report.

3 ASSET REALISATION

There were no asset realisations in this period.

4 OUTSTANDING ISSUES

HM Revenue & Customs (HMRC) have issued an assessment on the Company in relation to corporation tax and will be submitting a formal claim in due course.

5 DIVIDEND PROSPECTS

Unsecured claims totalling £22,751.40 have been received. Based on the information available to me, I do anticipate there being sufficient funds available to pay a dividend to creditors however the quantum and timing of any dividend is dependent on the claim submitted by HMRC.

6 LIQUIDATOR'S FEES

A SIP9 summarising the time costs accrued for the last accounting period from 24 June 2018 to 23 June 2019 is also attached. Time costs for the period are £1,811. This is a total of 12.90 hours at an average hourly rate of £140.39. Category two disbursements are £11.79.

At a previous meeting of creditors it was resolved that the Liquidator was authorised to draw from time to time further remuneration with reference to the time properly spent by him and his staff in attending to matters arising from the Liquidation and to repay any outlays necessarily incurred.

As per my previous progress report, the Liquidator has taken fees of £24,680.20 plus VAT and outlays of £51.79 plus VAT to date. Included within these amounts are fees of £2,143.20 plus VAT and outlays of £26.96 plus VAT which were taken in the period of this report. Future fees will be taken in due course.

A secured creditor, or an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question), or with the permission of the court upon an application made by any creditor, my request in writing any further information about remuneration or expenses set out above, provided that such request is made within 21 days of receipt of this report.

GREENWOOD MANAGEMENT LIMITED (IN LIQUIDATION)

Any creditor of the Company may, with the concurrence of at 25% in value of the creditors (including the creditor in question), apply to the court for an order that the Liquidator's remuneration be reduced, on the grounds that it is, in all the circumstances, excessive.

7 MATTERS INVESTIGATED

I carried out an investigation into the conduct of the directors and in particular the circumstances surrounding the insolvency of the Company. The appropriate submission regarding the directors' conduct in terms of the Company Directors Disqualification Act 1986 has been sent to the Insolvency Service.

8 GENERAL

A further progress report on the Liquidation will be sent to creditors in 12 months' time unless I am able to bring this case to conclusion prior to the close of the next accounting period.
