

- 2 Under 4 2 of the Deed, as continuing security for payment of the Secured Liabiliites, the Chargor with full title guarantee charged to the Chargee by way of first floating charge the whole of the Chargor's undertaking and assets at the date of the Deed and thereafter and wherever situated, which were not for any reason effectively charged (whether in law or equity) by way of a fixed security by the Deed
