On 15 May 2017 creditors passed resolutions by correspondence to fix the basis of the Liquidator's remuneration as follows:

- A fixed fee of £10,000 for undertaking the following categories of work in the Liquidation; Administration and Planning, Investigations, and Creditors.
- Recovery of all Category 1 and Category 2 disbursements.

1. Introduction

- 1.1 I am writing to provide you with my final report on the conduct of the Liquidation for the period from 22 February 2017 to 26 March 2018
- 1.2 This report should be read in conjunction with my first annual report to creditors which covered the period 22 February 2016 to 21 February 2017.

2. Receipts

- 2.1 A copy of the Receipts and Payments Account made up to 26 March 2018 is attached.
- 2.2 There have been no receipts during the period covered by this report.

3. Payments

- 3.1 In accordance with the resolutions passed at the S98 Meeting of Creditors, Booth & Co has received an amount in the sum of £2,741.18 plus VAT in respect of their fee for assisting the Director with the preparation of the Director's Report and Statement of Affairs and assisting the Director in convening the statutory meetings of members and creditors.
- 3.2 The only other payment made during the period has been a small amount of bank charges.

4. Secured Creditors

4.1 There are no secured creditors in this matter.

5. Preferential Creditors

5.1 There are no preferential creditors in this matter.

6. Unsecured Creditors

6.1 Insufficient funds have been realised to enable a dividend to be paid to unsecured creditors and in my letter dated 25 January 2018, creditors were provided with formal notice of no dividend in accordance with Rule 14.37 of the Insolvency (England and Wales) Rules 2016.

7. Directors' Conduct Report & Investigation

- 7.1 As required, I have submitted my confidential report to the Insolvency Service. I have also carried out my investigations into the conduct of the business.
- 7.2 Creditors will be aware from my previous annual progress report that I was investigating payments totalling £10,500 which were made to Mr Z Sharif in the 6 months preceding my appointment as Liquidator.
- 7.3 Schofield Sweeney solicitors were instructed to provide advice in relation to this matter and following an exchange of correspondence between them and Mr Sharif's advisors, additional documentation providing further details of the circumstances in which the payments were made was provided. Following a review of this documentation and following advice received from Schofield Sweeney, a decision was taken not to take any further action in relation to this matter.

7.4 I can therefore advise creditors, pursuant to the provisions of Statement of Insolvency Practice 2, that my investigations did not reveal any matters which would require me to take further action against any officer of the Company, or any third parties.

8. Liquidator's Remuneration

- 8.1 On 20 April 2017, I issued correspondence to creditors in which I sought approval for resolutions by which the Liquidator's remuneration would be calculated by reference to a fixed fee, and that the Liquidator would be entitled to recover all Category 2 disbursements. The final date for voting was 15 May 2017.
- 8.2 Accordingly a resolution was duly passed that the Liquidator may charge a fixed fee of £10,000 for undertaking the following categories of work in the Liquidation; Administration and Planning, Investigations, and Creditors.
- 8.3 Insufficient funds have been realised to enable any payment to be made in respect of the fixed fee referred to above.
- 8.4 Disbursements incurred amount to £400.72, details of which are provided below. The full amount has been written off as irrecoverable.

- 8.5 Category 1 disbursements relate to external services provided which are directly attributable to the case. Category 2 disbursements relate to shared or allocated costs which generally relate to internal charges made for items such as document storage, photocopying, room hire and mileage.
- 8.6 Creditor approval is required for Category 2 disbursements to be charged as an expense of the Liquidation in accordance with best practice guidelines as set out in Statement of Insolvency Practice 9.

9. Conclusion

9.1 The winding up of the Company is now for all practical purposes complete and I am seeking my release as Liquidator of the Company. Please note that provided no objections to my release are received I shall obtain my release as Liquidator following the delivery of the final notice to the Registrar of Companies.
