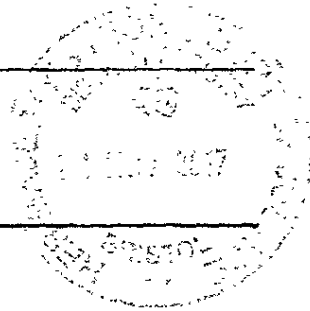

BLOCK TRANSFER ORDER

UPON READING the Application and the Witness Statement of Jeremiah Anthony O'Sullivan dated 19 October 2017.

AND UPON READING the consent of the Respondent to the terms of this Order.

IT IS ORDERED THAT:

1. TRANSFER BETWEEN COURTS

- 1.1. The cases set out in Schedule A and Schedule B appended to this Order, insofar as they are currently proceedings in any County Court or any District Registry are transferred to the High Court pursuant to Rule 12.38 (2)(a) Insolvency Rules 2016 ("IR16") solely for the purpose of making this Order.

2. APPLICANT'S REMOVAL AS OFFICEHOLDER

- 2.1. The Applicant, Jeremiah Anthony O'Sullivan, be removed as officeholder in the cases set out in Schedule A to this Order.
- 2.2. The Applicant, Jeremiah Anthony O'Sullivan, be removed as joint office holder in the case set out in Schedule B to this Order.

3. APPOINTMENT OF OFFICEHOLDERS

- 3.1. Jonathan Mark Williams be appointed in substitution of the Applicant as officeholder in the cases set out in the Schedule A to this Order.
- 3.2. The appointment set out above shall take effect from the date of this Order

3.3. Jonathan Mark Williams continues his appointment as office holder in the case set out in Schedule B to this Order, which from the date of this Order shall continue as an appointment in his sole name.

3.4. As soon as reasonably practicable, the Applicant shall file with each of the applicable courts mentioned in the Schedule hereto one copy of this Order for each case for filing on the Court file relating to that case.

4. ADVERTISEMENT AND REPORTING TO CREDITORS

4.1. The Applicant shall notify the Secretary of State of this Order as soon as reasonably practical after it is made.

4.2. The creditors of the respective estates shall be notified of the effect of this Order as soon as practicable by advertisement in the London Gazette as soon as practicable.

4.3. There shall be liberty to each creditor (or in the case of a solvent liquidation, each member) to apply to vary or discharge this Order insofar as it relates to the estate or liquidation of which they are a creditor (or member) within 28 days of being given notice of this Order.

5. TRANSFER BETWEEN COURTS

5.1. The cases specified in Schedule A and Schedule B to this Order are hereby transferred back to the County Court or District Registry from which they were transferred by the Order made in Paragraph 1 above, adopting the same case numbers used immediately before their transfer to the High Court, Bristol District Registry.

6. COSTS

6.1. There be no order as to costs.
