HMRC

HMRC were notified of my appointment. Corporation tax returns for all pre-liquidation periods were submitted by the Company's accountants, and all corporation tax liabilities were settled prior to the commencement of the liquidation. A corporation tax refund of £367.79 was received in respect of the accounting period to 31 March 2022.

I applied for formal tax clearance to conclude the liquidation. This has been received. I have responded to all information requests received from HMRC, and have not been notified by HMRC of any outstanding tax issues preventing the closure of the liquidation.

Distributions

On 10 November 2022 a first interim capital distribution of £406,000.00 per Ordinary share, totalling £812,000.00 was declared and paid to the members of the Company.

On 16 May 2023 a final capital distribution of £4,612.98 per Ordinary share, totalling £9,225.96 was declared and paid to the members of the Company.

Liquidator's remuneration and expenses

My remuneration was previously authorised by members at a meeting held on 31 October 2022 on a fixed fee basis of £2,750.00 plus VAT. This sum has been billed and drawn in full.
