Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant and machinery etc - 20% on reducing balance

The company's investment property was transferred from its parent company during the 31 March 2014 accounting year at market value. The value of the property has been increased to reflect its current market value at the balance sheet date.
