AND UPON HEARING Counsel for the Petitioner and the Company being neither present nor represented

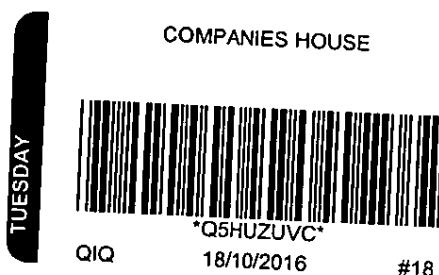
AND UPON READING the evidence
