#### Alifya Education Ltd

1 The company's name is Alifya Education Ltd (and in this document it is called the "charity")

#### Interpretation

#### 2 In the articles

"address" means a postal address or, for the purposes of electronic communication, a fax number, an'e-mail or postal address or a

address or telephone number for receiving text messages in each case registered with the charity,

"the articles" means the charity's articles of association,

"the charity" means the company intended to be regulated by the articles,

"clear days" in relation to the period of a notice means a period excluding

- the day when the notice is given or deemed to be given, and
- the day for which it is given or on which it is to take effect,

"the Commission" means the Charity Commission for England and Wales,

"Companies Acts" means the Companies Acts (as defined in section 2 of the Companies Act 2006) insofar as they apply to the charity,

"the directors" means the directors of the charity. The directors are

charity trustees as defined by section 177 of the Charities Act 2011,

"document" includes, unless otherwise specified, any document sent or supplied in electronic form,

"electronic form" has the meaning given in section 1168 of the Companies Act 2006,

"the memorandum" means the charity's memorandum of association,

"officers" includes the directors and the secretary (if any),

"the seal" means the common seal of the charity if it has one,

"secretary" means any person appointed to perform the duties of the secretary of the charity,

"the United Kingdom" means Great Britain and Northern Ireland, and words importing one gender shall include all genders, and the singular includes the plural and vice versa

Unless the context otherwise requires words or expressions contained in the articles have the same meaning as in the Companies Acts but excluding any statutory modification not in force when this constitution becomes binding on the charity

Apart from the exception mentioned in the previous paragraph a reference to an Act of Parliament includes any statutory modification or re-enactment of it for the time being in force

#### Liability of members

- 3 (1) The liability of the members is limited
- (2) Every member of the charity promises, if the charity is dissolved while he or she or it is a member or within twelve months after he or she or it ceases to be a member, to contribute such sum [not exceeding ten pounds (£10)] as may be demanded of him or her or it towards the payment of the debts and liabilities of the charity incurred before he or she or it ceases to be a member, and of the costs charges and expenses of winding up, and the adjustment of the rights of the contributories among themselves

#### **Objects**

- 4 The charity's objects ("Objects") are specifically restricted to the following
  - a) The advancement of education for children who are disadvantaged by reason of coming from immigrant communities by the provision of supplementary education
  - b) To advance the education of the public in the following subjects languages, in particular the Somali and Arabic languages, information technology, literacy and numeracy

# **Powers** 5 The charity has power to do anything which is calculated to further its Object(s) or is conducive or incidental to doing so. In particular, the charity has power (1) to raise funds. In doing so, the charity must not undertake any substantial permanent trading activity and must comply with any relevant statutory regulations, (2) to buy, take on lease or in exchange, hire or otherwise acquire any property and to maintain and equip it for use, (3) to sell, lease or otherwise dispose of all or any part of the property belonging to the charity In exercising this power, the power the charity must comply as appropriate with sections 117 and 122 of the Charities Act 2011, (4) to borrow money and to charge the whole or any part of the property belonging to the charity as security for repayment of the money borrowed or as security for a grant or the discharge of an obligation The charity must comply as appropriate with sections 124 -126 of the Charities Act 2011, if it wishes to mortgage land, (5) to co-operate with other charities, voluntary bodies and to exchange information and advice with them, (6) to establish or support any charitable trusts, associations or institutions formed for any of the charitable purposes included in the Objects, (7) to acquire, merge with or to enter into any partnership or joint venture arrangement with any other charity,

(8) to set aside income as a reserve against future expenditure but only in accordance with a

written policy about reserves,

(9) to employ and remunerate such staff as are necessary for carrying out the work of the charity. The charity may employ or remunerate a director only to the extent it is permitted to do so by article 6 and provided it complies with the conditions in that article,
(10) to
(a) deposit or invest funds,
(b) employ a professional fund-manager, and
(c) arrange for the investments or other property of the charity to be held in the name of a nominee,
in the same manner and subject to the same conditions as the trustees of a trust are permitted to do by the Trustee Act 2000,
(11) to provide indemnity insurance for the directors in accordance with, and subject to the conditions in, section 189 of the Charities Act 2011,
(12) to pay out of the funds of the charity the costs of forming and registering the charity both as a company and as a charity,

Application of income and property
•
6(1) The income and property of the charity shall be applied solely towards the promotion of the Objects
6(2) a) A director is entitled to be reimbursed from the property of the charity or may be paid out of such property reasonable expenses properly incurred by him or her when acting on behalf of the charity

- b) A director may benefit from trustee indemnity insurance cover purchased at the charity's expenses in accordance with, and subject to the conditions in, section 189 of the Charities Act 1993
- c) A director may receive an indemnity from the charity in the circumstances specified in article 56
- None of the income or property of the charity may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any member of the charity. This does not prevent a member who is not also a director receiving
  - a) a benefit from the charity in the capacity of a beneficiary of the charity,
  - b) reasonable and proper remuneration for any goods or services supplied to the charity

#### **Directors' Benefits**

- 6 4A No director or connected person may
  - (a) buy any goods or services from the charity on terms preferential to those applicable to members of the public,
  - (b) sell goods, services, or any interest in land to the charity,
  - (c), be employed by, or receive any remuneration from, the charity,
  - (d) receive any other financial benefit from the charity,
    - unless
      - (i) the payment is permitted by article 6(4)(B)(a), or
      - (11) the directors obtain the prior written approval of the Commission and fully comply with any procedures it prescribes
      - (111) In the case of employment or remuneration as per 6(4)A (c) above the charity complies with the procedure set out in clause 6(5)

- (i) A director or connected person may receive a benefit from the charity in the capacity of a beneficiary of the charity provided that a majority of the directors do not benefit in this way
  - (11) A director or connected person may enter into a contract for the supply of services, or of goods that are supplied in connection with the provision of services, to the charity where that is permitted in accordance with, and subject to the conditions in, section 185 and 186 of the Charities Act 2011
  - (III) Subject to article 6(4)(C) a director or connected person may provide the charity with goods that are not supplied in connection with services provided to the charity by the director or connected person
  - (iv) A director or connected person may receive interest on money lent to the charity at a reasonable and proper rate which must be 2% (or more) per annum below the base rate of a clearing bank to be selected by the directors
  - (v) A director or connected person may receive rent for premises let by the director or connected person to the charity if the amount of the rent and the other terms of the lease are reasonable and proper and provided that the director concerned shall withdraw from any meeting at which such a proposal of the rent of other terms of the lease are under discussion.
  - (vi) The directors may arrange for the purchase, out of the funds of the charity, of insurance designed to indemnify the directors in accordance with the terms of, and subject to the conditions in section 189 of the Charities Act 2011
  - (VII) A director or connected person may take part in the normal trading and fundraising activities of the charity on the same terms as members of the public

#### Payment for supply of goods only - controls

6 4C The charity and its directors may only rely upon the authority provided by article 6 4B(a)(iii) if each of the following conditions is satisfied

- (a) . The amount or maximum amount of the payment for the goods is set out in an agreement in writing between
  - (1) The charity or its directors (as the case may be), and
  - (ii) The director or connected person supplying the goods ('the supplier') under which the supplier is to supply the goods in question to or on behalf of the charity
- (b) The amount or maximum amount of the payment for the goods does not exceed what is reasonable in the circumstances for the supply of the goods in question
- (c) The other directors are satisfied that it is in the best interests of the charity to contract with the supplier rather than with someone who is not a director or connected person. In reaching that decision the directors must balance the advantage of contracting with a director or connected person against the disadvantages of doing so
- (d) The supplier is absent from the part of any meeting at which there is discussion of the proposal to enter into a contract or arrangement with him or her or it with regard to the supply of goods to the charity
- (e) The supplier does not vote on any such matter and is not to be counted when calculating whether a quorum of directors is present at the meeting
- (f) The reason for their decision is recorded by the directors in the minute book
- (g) A majority of the directors then in office are not in receipt of remuneration or payments authorised by article 6 4A
- 6 5 The Charity and its Directors may only rely upon the authority provided by subclause 6(4)(A)(d)(iii) if each of the following conditions is satisfied
  - (1) The remuneration or other sums paid to the Director do not exceed an amount that is reasonable in all the circumstances
  - (11) The Director is absent from the part of any meeting at which there is discussion of
  - his or her employment or remuneration, or any matter concerning the contract, or
  - his or her performance in the employment, or his or her performance of the contract, or

- any proposal to enter into any other contract or arrangement with him or her or to confer any benefit upon him or her that would be permitted under sub-clause 6(4)(B)(a)(iii), or
- any other matter relating to a payment or the conferring of any benefit permitted by sub-clause 6(4)(B)(a)(111)
- (III) The Director does not vote on any such matter and is not to be counted when calculating whether a quorum of Directors is present at the meeting
- (iv) The other Directors are satisfied that it is in the interests of the Charity to employ or to contract with that Director rather than with someone who is not a Director. In reaching that decision the Directors must balance the advantage of employing a Director against that disadvantages of doing so (especially the loss of the Director's services as a result of dealing with the Director's conflict of interest)
- (v) The reason for their decision is recorded by the Directors in the minute book
  - (vi) A majority of the Directors then in office have received no such payments
- (b) The employment or remuneration of a Director includes the engagement or remuneration of any firm or company in which the Director is:
  - (1) a partner,
  - (11) an employee,
  - (111) a consultant,
  - (iv) a director, or
  - (v) a shareholder, unless the shares of the company are listed on a recognised stock exchange and the Director holds less than 1% of the issued capital

At each subsequent annual general meeting one-third of the directors or, if their number is not three or a multiple of three, the number nearest to one-third, must retire from office. If there is only one director he or she must retire.
