Articles of Association of

Alifya Education Ltd

1 The company's name is Alifya Education Ltd (and in this document it is called the "charity").

Interpretation

2 In the articles

"address" means a postal address or, for the purposes of electronic communication, a fax number, an e-mail or postal address or a

address or telephone number for receiving text messages in each case registered with the charity,

"the articles" means the charity's articles of association,

"the charity" means the company intended to be regulated by the articles,

"clear days" in relation to the period of a notice means a period excluding:

- the day when the notice is given or deemed to be given, and
- the day for which it is given or on which it is to take effect,

"the Commission" means the Charity Commission for England and Wales,

"Companies Acts" means the Companies Acts (as defined in section 2 of the Companies Act 2006) insofar as they apply to the charity;

"the directors" means the directors of the charity. The directors are

charity trustees as defined by section 177 of the Charities Act 2011;

"document" includes, unless otherwise specified, any document sent or supplied in electronic form,

"electronic form" has the meaning given in section 1168 of the Companies Act 2006,

"the memorandum" means the charity's memorandum of association,

"officers" includes the directors and the secretary (if any);

"the seal" means the common seal of the charity if it has one;

"secretary" means any person appointed to perform the duties of the secretary of the charity;

"the United Kingdom" means Great Britain and Northern Ireland, and words importing one gender shall include all genders, and the singular includes the plural and vice versa

Unless the context otherwise requires words or expressions contained in the articles have the same meaning as in the Companies Acts but excluding any statutory modification not in force when this constitution becomes binding on the charity

Apart from the exception mentioned in the previous paragraph a reference to an Act of Parliament includes any statutory modification or re-enactment of it for the time being in force

Liability of members

- 3 (1) The liability of the members is limited.
- (2) Every member of the charity promises, if the charity is dissolved while he or she or it is a member or within twelve months after he or she or it ceases to be a member, to contribute such sum [not exceeding ten pounds (£10)] as may be demanded of him or her or it towards the payment of the debts and liabilities of the charity incurred before he or she or it ceases to be a member, and of the costs charges and expenses of winding up, and the adjustment of the rights of the contributories among themselves

Objects

4 The charity's objects ("Objects") are specifically restricted to the following -

The advancement of education for the children of disadvantaged families from immigrant communities by (but not limited to):-

a) brokering between the child, parents and schools to ensure parents' constant awareness of their child's academic needs and targets

- b) providing extra classes to help children fully prepare for their national curriculum school exams
- c) developing CV writing and interview skills
- d) providing Somali language writing and reading classes
- e) providing Arabic language writing and reading
- f) providing Islamic studies

Powers

- 5 The charity has power to do anything which is calculated to further its Object(s) or is conducive or incidental to doing so. In particular, the charity has power
- (1) to raise funds In doing so, the charity must not undertake any substantial permanent trading activity and must comply with any relevant statutory regulations,
- (2) to buy, take on lease or in exchange, hire or otherwise acquire any property and to maintain and equip it for use,
- (3) to sell, lease or otherwise dispose of all or any part of the property belonging to the charity In exercising this power, the power the charity must comply as appropriate with sections 117 and 122 of the Charities Act 2011;
- (4) to borrow money and to charge the whole or any part of the property belonging to the charity as security for repayment of the money borrowed or as security for a grant or the discharge of an obligation. The charity must comply as appropriate with sections 124-126 of the Charities Act 2011, if it wishes to mortgage land;
- (5) to co-operate with other charities, voluntary bodies and to exchange information and advice with them,
- (6) to establish or support any charitable trusts, associations or institutions formed for any of the charitable purposes included in the Objects;

| (7) to acquire, merge with or to enter into any partnership or joint venture arrangement with any other charity, |

| (11) to provide indemnity insurance for the directors in accordance with, and subject to the conditions in, section 189 of the Charities Act 2011, |
| (12) to pay out of the funds of the charity the costs of forming and registering the charity both as a company and as a charity, |
| Application of income and property |
| 6(1) The income and property of the charity shall be applied solely towards the promotion of the Objects |

a) A director is entitled to be reimbursed from the property of the charity or may be 6(2)paid out of such property reasonable expenses properly incurred by him or her when acting on behalf of the charity. b) A director may benefit from trustee indemnity insurance cover purchased at the charity's expenses in accordance with, and subject to the conditions in, section 189 of the Charities Act 1993 c) A director may receive an indemnity from the charity in the circumstances specified in article 56 6(3)None of the income or property of the charity may be paid or transferred directly or indirectly by way of dividend bonus or otherwise by way of profit to any member of the charity. This does not prevent a member who is not also a director receiving a) a benefit from the charity in the capacity of a beneficiary of the charity, reasonable and proper remuneration for any goods or services supplied to the charity **Directors' Benefits** 6 4A No director or connected person may (a) buy any goods or services from the charity on terms preferential to those applicable to members of the public; (b) sell goods, services, or any interest in land to the charity; (c) be employed by, or receive any remuneration from, the charity; (d) receive any other financial benefit from the charity, unless (1) the payment is permitted by article 6(4)(B)(a); or

- (11) the directors obtain the prior written approval of the Commission and fully comply with any procedures it prescribes.
- (111) In the case of employment or remuneration as per 6(4)A (c) above the charity complies with the procedure set out in clause 6(5)

6 4B(a)

- (1) A director or connected person may receive a benefit from the charity in the capacity of a beneficiary of the charity provided that a majority of the directors do not benefit in this way.
- A director or connected person may enter into a contract for the supply of services, or of goods that are supplied in connection with the provision of services, to the charity where that is permitted in accordance with, and subject to the conditions in, section 185 and 186 of the Charities Act 2011
- (iii) Subject to article 6(4)(C) a director or connected person may provide the charity with goods that are not supplied in connection with services provided to the charity by the director or connected person
- (1v) A director or connected person may receive interest on money lent to the charity at a reasonable and proper rate which must be 2% (or more) per annum below the base rate of a clearing bank to be selected by the directors
- (v) A director or connected person may receive rent for premises let by the director or connected person to the charity if the amount of the rent and the other terms of the lease are reasonable and proper and provided that the director concerned shall withdraw from any meeting at which such a proposal of the rent of other terms of the lease are under discussion
- (vi) The directors may arrange for the purchase, out of the funds of the charity, of insurance designed to indemnify the directors in accordance with the terms of, and subject to the conditions in section 189 of the Charities Act 2011
- (vii) A director or connected person may take part in the normal trading and fundraising activities of the charity on the same terms as members of the public.

- 6 4C The charity and its directors may only rely upon the authority provided by article 6 4B(a)(iii) if each of the following conditions is satisfied
 - (a) The amount or maximum amount of the payment for the goods is set out in an agreement in writing between.
 - (1) The charity or its directors (as the case may be); and
