

### Progress Report

I was appointed Liquidator of the Company on 1 October 2020 and this is my final progress report to the members of the Company, showing how the liquidation has been conducted. The report covers the period from 1 October 2020 to 27 August 2021.

Following the realisation of all assets comprised within the estate, the clearance of all known tax liabilities and discharge of all other known debts of the Company incurred prior to and subsequent to my appointment and there appearing to remain no further debts, a final distribution was declared and paid to members on 26<sup>th</sup> February 2021.

### Distribution Information

The members of the Company received a total capital distribution of £147,058.00 equating to £1,470.58 for each share held in the Company, which was paid as follows:-


