

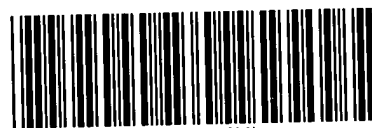

The principal activity of the company in the year under review was that of Courier Service.

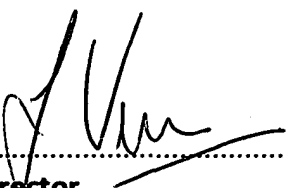

1. Accounting Policies

1.1 Accounting Convention

The Financial Statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2007).

1.2 Turnover

Turnover represents service provided net of Value Added Tax.

1.3 Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life, or if held under a Financial Lease, over the lease terms, whichever is the shorter.

Motor Vehicles	-	18% on reducing balance
Computer Equipment	-	15% on reducing balance

1.4 Deferred Tax

Deferred tax is recognised in respect of all timing differences that have originated but not reserved at the balance sheet date.

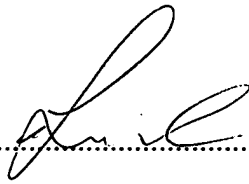
