1 Statutory information

Over the past year Knots Arts has expanded it's provision to support children and young people with social communication difficulties in two additional London Boroughs. In Richmond we ran 30 weeks of drama sessions for young people aged 4-16 years old and 30 weeks of youth club activities for those aged 12-25. We launched a new group specifically for girls with autism in London Borough of Sutton aged 6-18 years, running 30 weeks of sessions, as well as a new youth club for young people with social communication difficulties in Croydon for those aged 10-25, running 25 sessions throughout the year.

We have also run another two weeks of summer holiday projects for children and young people in Richmond, as well as a two day Easter holiday pilot project for young people in Richmond.

With this expansion we have grown from supporting 69 children and young people in 2015-16 to supporting 90 children and young people across 2016-17.

We support young people to give feedback during sessions, as well as collecting both verbal and written feedback from parents on a termly basis. All of our sessions are developed and shaped around the needs and suggestions of our children and young people and their families.

We also consult with our volunteers and staff members to take on board new ideas and ensure that they feel valued and a part of our team. This consultation adds value for our children and young people as we are able to think more creatively about ways to support them when pulling from a broader pool.

Drama in Richmond

Our drama sessions in Richmond continue to support a growing number of children and young people with autism and social communication difficulties. Over the course of the year the number of children attending sessions steadily rose. We supported 35 children to access these sessions throughout the year.

Feedback from these children and their parents also continues to be positive. Many parents state that it is the activity that their child looks forward to most over the course of the week.

We have also seen benefits for children around increased confidence and ability to make friendships, one parent told us:

Freddie has become much more interactive. He spears more alert and responsive when you speak to him and is keen to contribute ideas for discussion. Regularly asking questions (something he rarely did before). He certainly seems keener than ever to engage with his peers. A couple of his closest school friends have invited him to play date recently that suggests he is having some success engaging with them.

Youth Club in Richmond

In addition to the 30 youth club sessions, we also supported youth club members to go on trips to activities and attractions in London. Over the course of the year we attended a performance of the Tempest at the Orange Tree Theatre and went to a trampoline park amongst other activities.

Alongside regular activities such as sport, cookery and games, we also undertook new, longer term projects. In the summer term we brought in a film maker and created our own music video at the request of the young people, which was a really positive experience.

We supported 20 young people to access this group throughout the year.

Youth Club in Croydon

In November 2016 we embarked upon a new youth club project in South Norwood, Croydon. The group was set up in response to need for our kind of services in the area, identified through Knots Arts staff members working in Croydon. The group runs in the same format to the Richmond Youth Club, and we have undertaken a number of life skills and confidence building activities over the course of the year.

At the end of the school year we had 8 group members, and are planning to continue to grow the group over the coming school year.

Girls Group in Sutton

In September 2016 we began two new groups specifically for girls with social communication difficulties in London Borough Sutton. These groups were set up after we were approached by a parents group, South West London Girls Connect, who had identified a need amongst their members for a creative activities group for their children.

The sessions have been incredibly well attended, with 22 girls benefiting throughout the year. Girls are grouped by age, with a group for 6 – 10 years and 11 - 16 years.

Sessions have covered a wide range of activities, from arts and crafts to drama, cookery, dressing up and healthy relationships. These sessions are fully subscribed and we plan to continue them into the following school year.

Play in a Week 2016

In August 2016 we embarked upon our first Play in a Week holiday project. We worked with 9 young people aged 10 – 21 to devise and perform a new piece of work based around the poem, The Quangle Wangles Hat. The project was a huge success, with young people really enjoying the week and making new friends. Of the 9 young people we worked with, 7 already attended our drama and youth club sessions and two were new to our groups.

Easter Holiday project 2017

In April 2017 we ran a two day puppetry project at the Holly Lodge Centre in Richmond Park.

We worked with 9 young people aged 10 - 18 to create our own puppets and explore the nature trail, creating a short sharing performance.

The project was our first in conjunction with the Holly Lodge Centre, and we plan to embark upon further project of this nature over the coming year.

Play in a Week 2017

In July 2017, we finished the year with another Play in a Week project. This summer we worked with 11 young people aged 10-21, creating a performance based around the Grimm Fairytales. Of these 11 young people 10 were already known to us, with one new member joining us for the first time.

The performance was created over the course of a week and performed for parents and carers at the OSO in Barnes on 28th July 2017.

We ensure we work closely with our funders, such as BBC Children in Need, The Rowan Bentall Charitable Trust and Sutton Community Fund, to identify their requirements and make sure our evaluation and monitoring procedures are both

robust enough to meet their needs as well as being able to provide detailed feedback to parents and carers, often feeding into evidence to get further support for children from the local authority.

We have also worked on building partnerships with other local organisations such as Action-Attainment, Me Too & Co and Activity Station, who are doing similar work, involving them in the sharing of ideas and marketing to reach wider audience for mutually beneficial outcomes.
