The company was incorporated on 30 July 2013. The company is limited by guarantee (provided by the Directors) and does not trade with a view to profit.

DIVIDENDS AND TRANSFERS TO RESERVES

As the company generates income only to cover its eventual liabilities, no dividend is recommended and all surpluses and deficiencies are transferred between appropriate reserves.

DIRECTORS

The directors during the year were Ms East, Ms Yates & Ms Hand. Each receive payments for their work on activities with the Youth Clubs & Drama group.

Over the course of 2014-15 we have run drama and youth club sessions for young people aged between 4 – 23 in London. Our main services were delivered in the Borough of Richmond. 30 youth club sessions were delivered between September 2014 and July 2015, supporting 13 young people aged 14-23 with social communication difficulties such as autism or Asperger's.

We ran 30 weeks of drama sessions, comprising of 105 hour long sessions over the year Initially we were supporting 14 children through 3 sessions per week in September 2014, this had risen to 20 children through 4 sessions per week by the end of July 2015. Children accessing drama sessions were aged between 4 and 16. Again, all of these children were experiencing some form of social communication difficulty, such as autism, Asperger's or ADHD. All drama sessions were delivered by our drama leaders and supported twice termly by a qualified speech and language therapist.

Between January – April 2015 we also ran a small drama pilot in the borough of Southwark supporting 6 children aged 5-7 with social communication difficulties

The children and young people that we work with and their families our are main stakeholders. Our freelance staff and volunteers alongside our funders and wider circle of supporters also play a stake holder role in our work.

Young people's need and views continually feed into the work that we carry out at Knots Arts At the beginning of each term the drama leader and youth leader work with the children and young people to set a theme or a programme of activities for the term. This is then carried out with the input of the children and young people throughout. For example children in drama help to choose games and activites played each week and youth club members plan their end of term trips, assisted by youth club staff and volunteers. There is continued discussion and consultation with parents on suitable and relevant activities and the specific needs of their child. This ensures that the support we offer is making a direct impact on their social communication needs.

Drama in Richmond

Feedback from the children, young people and their parents/carers continues to be incredibly positive. We continue to see improvements in group members ability to communicate, especially with their peers, leading to an increase in friendships and confidence. One parents told us

"My child benefits from the small class size as it means the teachers can better support his needs. The additional support has also helped boost his confidence and helped give him the courage to speak in a group. He is learning important life skills such as the art of two way conversation, listening, supporting friends and following instructions while having lots of fun. Also the slower pace and repetition enables my son to keep up with the activities whereas in a mainstream class he often struggles to keep up. Knots drama boosts my sons confidence as his class has kids with similar difficulties so no one feels judged."

Drama in Southwark (pilot project)

In addition to our established sessions in Richmond we ran a 10 week pilot drama session for children in Southwark. The 6 children who took part all had social communication difficulties and were attending a mainstream school in North Dulwich. The pilot focused on working with the school to identify children who could benefit from our support and was well received by parents and carers. Unfortunately due to the closure of the children's centre where these sessions were hosted the pilot will not be going forward as a permanent project as had been planned.

Dramatherapy

Through feedback from parents we began offering referrals for a 1 1 dramatherapy service for children who could benefit from specific therapeutic input. This service is delivered by a trained drama therapist and has so far been taken up by one member of the drama group to great effect.

Youth Club

In addition to the 30 youth club sessions, we also supported youth club members to go on 5 trips to attractions in London visiting the Imperial War Museum, the Cartoon Museum and the Tate Modern as well as having a meal out at Nando's in Richmond and having a day of Bowling and Lazerquest in Feltham

Many members of our youth club tell us that it is their favourite part of the week, with many arriving early and not wanting to leave at the end of sessions. Many of these young people struggle to make friends in a mainstream setting but have developed lasting and meaningful relationships with other members of the group.

One parent told us

"My son benefits from attending Knots Arts as it is his only social activity where he just meets his peers He does not take part in other clubs (except a

football session that he goes to with his Dad) and his other activities are solitary or usually with adults. Knots Arts is different because he is able to come and go independently and he has more freedom, I believe, to do (or not do) what he would like when he is at the club. He is not a "joiner in" but he is always happy to come along to youth club."

We also continually seek the input and ideas of our freelance staff and volunteers to ensure that we are both offering the best possible support for children and young people as well as helping staff to develop their practice and delivery skills

We ensure we work closely with our funders, such as BBC Children in Need, to identify their requirements and make sure our evaluation and monitoring procedures are both robust enough to meet their needs and give useful and practical feedback to parents and carers
