NOTES TO THE FINANCIAL STATEMENTS**1. AVERAGE NUMBER OF EMPLOYEES**

The average number of employees during the year was 1 (2020 - 1) .

2. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES

During the year, J Boakes decreased his loan to the company. As at 31 August 2021, the company owed him £137 (2020: £5,839). This balance represented the maximum amount outstanding during the year and the loan is interest free and repayable on demand.

Also during the year, the company paid J Boakes rent amounting to £1,000 (2020: £366) as a result of utilising office space within his home.

3. POST BALANCE SHEET EVENTS

Prior to the balance sheet date and prior to the approval of these accounts the 2020 outbreak of the COVID-19 virus persisted, remaining a global pandemic recognised by the World Health Organisation (WHO).

The ongoing effect of UK Government measures to limit the spread of the virus have been widespread, urging people to remain at home wherever possible, including to work from home if available and to undertake "social distancing" measures. Part of the government action has been to order businesses where people gather socially to close temporarily.

In response to this management of the company have assessed the impact of these measures and have applied to take up the UK Government's unprecedented business aid package by claiming the Coronavirus Job Retention Scheme. Due to the Government relaxing these measures the company has continued to see sales recover after the balance sheet date.

The director continues to monitor the situation as it rapidly changes and will react to further developments.
