**1 Statutory information**

NUZHAT & KHALID LTD is a private company, limited by shares, registered in England and Wales, registration number 08664017. The registered office is 27 GLENDINNING WAY, MADELEY, TELFORD, TF7 5SX.

**2 Guarantees and other financial commitments**

On 3rd March 2016, the company failed to pay agreed installment for the purchase of property due to restoration issues with the Companies House. As a result, there is a risk of losing all investment of £170,570. There is no provision made for this loss in these financial statements.

**3 Average number of employees**

During the year the average number of employees was 0 (2019: 0).

For the year ending 31 August 2020 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.

The director acknowledges his responsibilities for complying with the requirements of the Act with respect to accounting records and the preparation of accounts.

These accounts have been prepared in accordance with the micro-entity provisions of the Companies Act 2006 and FRS 105, The Financial Reporting Standard applicable to the Micro-entities Regime.
