## IT IS ORDERED

  - b. Claire Buijs be appointed as liquidator.

  - a. Kevin James Wilson Weir be removed as liquidator;
  - b. Claire Buijs be appointed as liquidator.
- 5. That, in respect of each individual voluntary arrangement listed in Schedule D attached hereto, pursuant to section 263 of the Insolvency Act 1986:
  - a. Kevin James Wilson Weir be removed as supervisor;
  - b. Claire Buijs be appointed as supervisor.
- That notice of each of the above removals of officeholder and each of the above appointments be given to creditors in accordance with the relevant provisions of the insolvency Rules 1986.
- 7. That Kevin James Wilson Weir be released from office in respect of each appointment set out in paragraphs 1a, 2a and 3a above 28 days after notice shall have been given to creditors in accordance with paragraph 6 above.
- 8. That the effects of rules 1.56, 2.47, 4.49C, r 4,49B and 6.78A be suspended so that the appropriate dates in respect of each officeholder's reporting obligations be unaffected by this application and that in each case the dates shall remain the same as they would have been had this application not been made.
- 9. That forthwith after the making of this order all cases transferred to this court pursuant to paragraph 1 above be transferred back to the County Courts whence they came.
- 10. That there be no order as to costs.
