THIS DEED is dated 30 October 2014 and made between

- (1) AMEYCESPA (AWRP) SPV LIMITED, registration number 08717850, as chargor (the "**Chargor**"), and
- (2) NORDDEUTSCHE LANDESBANK GIROZENTRALE (LONDON BRANCH) as security trustee for the Secured Creditors (the "**Security Trustee**")

### **Background**

- (A) By a common terms agreement dated on or about the date of this Deed (the "**Common Terms Agreement**") between among others, the Chargor, HoldCo, the Arrangers, the Original Commercial Lenders named in that agreement, EIB, Norddeutsche Landesbank Girozentrale (London Branch) as the Intercreditor Agent, the Security Trustee, the Account Bank, and the Commercial Facility Agent and the Original Hedging Banks, certain of the Senior Creditors have agreed, subject to the terms and conditions of the Common Terms Agreement and the other Finance Documents, to record certain obligations of the Chargor, in relation to the Project
- (B) The Chargor has entered into the EIB Finance Contracts with EIB pursuant to which EIB has agreed to make available to the Chargor loan facilities on the terms of, and subject to the conditions set out in, the EIB Finance Contracts
- (C) The Chargor has entered into the Commercial Facilities Agreement with the Commercial Lenders pursuant to which the Commercial Lenders have agreed to make available to the Chargor loan facilities on the terms of, and subject to the conditions set out in, the Commercial Facilities Agreement
- (D) The Obligors wish to finance the Project from *inter alia* the net proceeds of the advances under the EIB Finance Contracts and the Commercial Facilities Agreement
- (E) The board of directors of the Chargor is satisfied that entering into this Deed would be most likely to promote the success of the Chargor for the benefit of its members as a whole and to the further benefit and advantage of the Chargor
- (F) The Security Trustee and the Chargor intend this document to take effect as a deed (even though the Security Trustee only executes it under hand)
- (G) The Security Trustee holds the benefit of this Deed for the Secured Creditors on the terms of the Finance Documents

IT IS AGREED as follows

## **1 Definitions and interpretation**

### **1.1 Definitions**

In this Deed

**"Account Bank Agreement"** means the account bank agreement dated on or about the date of this Deed between, among others, the Chargor and Norddeutsche Landesbank Girozentrale (London Branch) as Intercreditor Agent and Account Bank

**"Administrator"** means an administrator appointed under Schedule B1 to the Insolvency Act

**"Agreements"** means, in relation to the Chargor, all its right, title and interest from time to time in and to the agreements to which it is a party described in Schedule 5 (*Agreements*) and all Related Rights

**"Assigned Accounts"** means the Bank Accounts described in Schedule 3 (*Assigned Accounts*)

**"Bank Accounts"** means, in relation to the Chargor, all its right, title and interest from time to time in and to all current, deposit or other accounts (other than the Distribution Account) with any bank or financial institution, all balances from time to time standing to the credit of or accrued or accruing on those accounts and all Related Rights

**"Delegate"** means a delegate or sub-delegate appointed by the Security Trustee or a Receiver in accordance with this Deed

**"Fixtures"** means fixtures, fittings and fixed plant, machinery and apparatus

**"Head Lease"** means any lease pursuant to which title to any Real Property is vested in the Chargor

**"HoldCo"** means Ameycespa (AWRP) Holding Co Limited, registration number 08717836

**"Insolvency Act"** means the Insolvency Act 1986

**"Insurances"** means, in relation to the Chargor, all its right, title and interest from time to time in and to all contracts and policies of insurance of any kind taken out by or on behalf of it and all Related Rights

**"Intellectual Property"** means, in relation to the Chargor, all its right, title and interest from time to time in and to

- (a) any patents, trade marks, service marks, designs, business names, copyrights, database rights, design rights, domain names, moral rights, inventions, confidential information, knowhow and other intellectual property rights and interests, whether registered or unregistered, and
- (b) the benefit of all applications and rights to use such assets,

and all Related Rights (in each case including any related licences and sub-licences of the same granted by it or to it, applications and rights to apply for the same)

**"Investments"** means, in relation to the Chargor, all its right, title and interest from time to time in and to

- (a) shares, stocks, debentures, units, bonds, notes, commercial paper, certificates of deposit, depository interests, securities and other investments,
- (b) warrants, options and other rights to subscribe for, purchase or otherwise acquire securities and investments,
- (c) any other securities or investments deriving from Investments or any rights attaching or relating to securities or investments,



in each case now or in the future owned by it or (to the extent of its interest) in which it now or in the future has an interest

**"Law of Property Act"** means the Law of Property Act 1925

**"Occupational Lease"** means any lease or contractual licence or other right of occupation of all or any part of any Real Property

**"Party"** means a party to this Deed

**"Plant and Machinery"** means, in relation to the Chargor, all its right, title and interest from time to time in and to all plant and machinery and all Related Rights

**"Quasi Security"** means a transaction under which the Chargor will

- (a) sell, transfer or otherwise dispose of any of its assets on terms whereby they are or may be leased to or re-acquired by any Obligor,
- (b) sell, transfer or otherwise dispose of any of its receivables on recourse terms,
- (c) enter into any arrangement under which money or the benefit of a bank or other account may be applied, set-off or made subject to a combination of accounts, or
- (d) enter into any other preferential arrangement having a similar effect,

in circumstances where the arrangement or transaction is entered into primarily as a method of raising Financial Indebtedness or of financing the acquisition of an asset

**"Real Property"** means, in relation to the Chargor, all its right, title and interest from time to time in and to any freehold or leasehold property in England and Wales and other real property anywhere in the world, all Fixtures from time to time on that property, and all Related Rights

**"Receivables"** means, in relation to the Chargor, all its right, title and interest from time to time in and to all book and other debts of any nature, all other rights to receive money (excluding Bank Accounts), and all Related Rights

**"Receiver"** means a receiver and manager or other receiver appointed in respect of all or any part of the Security Assets and shall, if allowed by law, include an administrative receiver

**"Related Rights"** means, in relation to a Security Asset

- (a) any proceeds of sale, transfer or other disposal, lease, licence, sub-licence, or agreement for sale, transfer or other disposal, lease, licence or sub-licence, of that Security Asset,
- (b) any moneys or proceeds paid or payable deriving from that Security Asset,
- (c) any rights, claims, guarantees, indemnities, Security or covenants for title in relation to that Security Asset,
- (d) any awards or judgments in favour of the Chargor in relation to that Security Asset, and

- (e) any other assets deriving from, or relating to, that Security Asset

**"Secured Liabilities"** means all present and future debts, claims, liabilities and payment obligations at any time due, owing or incurred by the Obligors to any Secured Creditor under or in connection with the Finance Documents (in each case, whether alone or jointly, or jointly and severally, with any other person, whether actually or contingently and whether as principal, surety or otherwise)

**"Security Assets"** means the assets which from time to time are, or expressed to be, the subject of the Security Interests or any part of those assets

**"Security Interests"** means all or any of the Security created or expressed to be created in favour of the Security Trustee by or pursuant to this Deed

## 1 2 Incorporation of defined terms

Unless a contrary indication appears, terms defined in or defined by reference in the Common Terms Agreement have the same meaning in this Deed

## 1 3 Construction

- (a) Any reference in this Deed to a **"Finance Document"** or any other agreement or instrument is a reference to that Finance Document or other agreement or instrument as amended, novated, supplemented, extended, restated (however fundamentally and whether or not more onerously) or replaced and includes any change in the purpose of, any extension of or any increase in any facility or the addition of any new facility under that Finance Document or other agreement or instrument
- (b) The provisions in Clause 1 10 (*Construction*) of the Common Terms Agreement apply to this Deed, except that references to the Common Terms Agreement or "this Agreement" shall be construed as references to this Deed

## 1 4 Third party rights

- (a) Unless expressly provided to the contrary in a Finance Document, a person who is not a Party has no right under the Contracts (Rights of Third Parties) Act 1999 (the **"Third Parties Act"**) to enforce or to enjoy the benefit of any term of this Deed
- (b) Notwithstanding any term of any Finance Document, the consent of any person who is not a Party is not required to rescind or vary this Deed at any time
- (c) Any Receiver, or any delegate of the Security Trustee or any Receiver, may, subject to this Clause 1 4 and the Third Parties Act, rely on any Clause of this Deed which expressly confers rights on it

## 1 5 Disposition

The terms of the other Finance Documents and of any other agreement or instrument between the Parties are incorporated into each Finance Document to the extent required for any disposition or purported disposition of all or any part of any Real Property or any other relevant Security Asset contained in any Finance Document to be a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989

## **1 6 Intercreditor Agreement**

In exercising any right, power or discretion or taking any action, step or proceeding hereunder, the Security Trustee shall do so pursuant to and in accordance with the Intercreditor Agreement and the Security Trustee shall have all the protections conferred on it pursuant to the Intercreditor Agreement, all of which shall be incorporated herein mutatis mutandis as if set out in full in this Deed

## **2 Security Interests**

### **2 1 Creation of Security Interests**

- (a) The Chargor with full title guarantee and as security for the payment of all Secured Liabilities, charges in favour of the Security Trustee
  - (i) by way of first legal mortgage, all Real Property in England and Wales (including that described in Schedule 2 (*Real Property*)) owned by it on the date of this Deed,
  - (ii) by way of first fixed equitable charge all other Real Property owned by it on the date of this Deed, all Real Property acquired by it after the date of this Deed and, to the extent not validly and effectively mortgaged under sub-paragraph (i) above, all Real Property in England and Wales owned by it on the date of this Deed,
  - (iii) by way of first fixed charge, all its Bank Accounts, to the extent not validly and effectively assigned under paragraph (b) below,
  - (iv) by way of first fixed charge, all its Receivables, to the extent not validly and effectively assigned under paragraph (c) below,
  - (v) by way of first fixed charge, all its Investments and a first fixed equitable charge over all Investments acquired by it after the date of this Deed,
  - (vi) by way of first fixed charge, all its right, title and interest from time to time in and to its uncalled capital and goodwill,
  - (vii) by way of first fixed charge, all its Intellectual Property and a first fixed equitable charge over all its Intellectual Property acquired by it after the date of this Deed (including that described in Schedule 4 (*Intellectual Property*)),
  - (viii) by way of first fixed charge, all its Plant and Machinery (except that validly and effectively mortgaged or charged under paragraph (i) or paragraph (ii) above) and a first fixed equitable charge over all its Plant and Machinery acquired by it after the date of this Deed,
  - (ix) by way of first fixed charge, all its Insurances, to the extent not validly and effectively assigned under paragraph (d) below, and
  - (x) by way of first floating charge, all its undertaking and all its assets, both present and future (including assets expressed to be mortgaged, charged or assigned under this Clause 2 1)
- (b) The Chargor, with full title guarantee and as security for the payment of all Secured Liabilities, assigns to the Security Trustee by way of security all its Assigned Accounts

- (c) The Chargor, with full title guarantee and as security for the payment of all Secured Liabilities, assigns to the Security Trustee by way of security all its Agreements
- (d) The Chargor, with full title guarantee and as security for the payment of all Secured Liabilities, assigns to the Security Trustee by way of security all its Insurances

## **2 2 Qualifying floating charge**

- (a) The floating charge created by the Chargor under Clause 2 1 (*Creation of Security Interests*) is a "qualifying floating charge" for the purposes of paragraph 14 2(a) of Schedule B1 to the Insolvency Act
- (b) Paragraph 14 of Schedule B1 to the Insolvency Act shall apply to this Deed and the Security Trustee may appoint an Administrator of the Chargor pursuant to that paragraph

## **2 3 Ranking**

The floating charge created by the Chargor under Clause 2 1 (*Creation of Security Interests*) ranks

- (a) behind all the mortgages, fixed charges and assignments created by the Chargor, but
- (b) in priority to any other Security over the Security Assets of the Chargor except for Security ranking in priority in accordance with paragraph (g) of Schedule 1 (*Rights of Receivers*)

## **2 4 Conversion by notice**

The Security Trustee may convert the floating charge over all or any of the Security Assets into a fixed charge by notice to the Chargor specifying the relevant Security Assets

- (a) if it considers it reasonable and desirable to do so in order to protect or preserve the Security Interests over those Security Assets and/or the priority of those Security Interests, and/or
- (b) while an Event of Default is continuing

## **2 5 Automatic conversion**

If

- (a) the Chargor takes any step to create any Security or Quasi Security in breach of Clause 3 1 (*Negative pledge*) over any Security Asset subject to the floating charge, or
- (b) any person takes any step to effect any expropriation, attachment, sequestration, distress or execution against any such Security Asset,

the floating charge over the relevant Security Assets shall automatically and immediately be converted into a fixed charge

## **2 6 Company voluntary arrangement moratorium**

Obtaining a moratorium or doing anything with a view to obtaining a moratorium pursuant to Schedule A1 to the Insolvency Act (including any preliminary decision or investigation) shall not cause the floating charge over all or any of the Security Assets to crystallise until the date upon which it is permitted to crystallise in accordance with paragraph 13 of Schedule A1 to the Insolvency Act

## **2 7 Consents**

If the consent of any party to a document is required to create fixed security over, or an assignment of, the rights of the Chargor under that document

- (a) the Chargor shall promptly notify the Security Trustee,
- (b) until the consent of the relevant party has been obtained, this Deed shall secure all amounts which the Chargor may receive, or has received, under that document but exclude any fixed security over, or any assignment of, those rights,
- (c) unless the Security Trustee requires otherwise, the Chargor shall use reasonable endeavours to obtain the consent of the relevant party to the creation of fixed security over or, as the case may be, an assignment of, those rights under this Deed as soon as reasonably practicable, and
- (d) on the date on which the consent of the relevant party is obtained, the fixed security over or, in respect of an asset expressed to be subject to an assignment, the assignment of, those rights under this Deed shall attach to those rights

## **3 Restrictions on dealing with Security Assets**

### **3 1 Negative pledge**

The Chargor shall not create or permit to subsist any Security or Quasi Security over any Security Asset, except as permitted by the Common Terms Agreement

### **3 2 Disposals**

The Chargor shall not enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to sell, lease, transfer or otherwise dispose of any Security Asset, except as permitted by the Common Terms Agreement

## **4 Further assurance**

- (a) The Chargor shall (at its own expense) promptly do all such acts or execute all such documents (including assignments, transfers, mortgages, charges, notices and instructions) as the Security Trustee may reasonably specify (and in such form as the Security Trustee may reasonably require in favour of the Security Trustee or its nominee(s))
  - (i) to perfect the Security created or intended to be created under or evidenced by this Deed (which may include the execution of a mortgage, charge, assignment or other Security over all or any of the assets which are, or are intended to be, the subject of the Security Interests) or for the exercise of any rights, powers and remedies of the Security Trustee or the Secured Creditors provided by or pursuant to the Finance Documents or by law, or
  - (ii) to confer on the Security Trustee or confer on the Secured Creditors Security over any property and assets of the Chargor located in any jurisdiction equivalent or similar to the Security intended to be conferred by or pursuant to this Deed, and/or
  - (iii) to facilitate the realisation of the assets which are, or are intended to be, the subject of the Security Interests

- (b) The Chargor shall take all such action as is available to it (including making all filings and registrations) as may be necessary for the purpose of the creation, perfection, protection or maintenance of any Security conferred or intended to be conferred on the Security Trustee or the Secured Creditors by or pursuant to this Deed

## **5 Real Property**

### **5.1 Notification**

The Chargor shall promptly notify the Security Trustee of its acquisition or disposal of, or agreement to acquire or dispose of, any Real Property

### **5.2 Documents**

The Chargor shall promptly deposit with the Security Trustee, and the Security Trustee shall be entitled to hold, all title deeds and documents relating to the Chargor's present and future Real Property

### **5.3 Present Real Property**

The Chargor shall, in respect of all Real Property in England and Wales owned by it on the date of this Deed

- (a) promptly apply to the Land Registry for first registration of that Real Property (where that Real Property is capable of being registered at the Land Registry and is not already so registered) and for registration of it as proprietor of that Real Property,
- (b) promptly apply to the Land Registry to register the Security created by paragraph (a)(i) and, if requested by the Security Trustee (and to the extent practicable), paragraph (a)(ii) of Clause 2.1 (*Creation of Security Interests*),
- (c) promptly apply to the Land Registry requesting
  - (i) a restriction in the form specified by the Security Trustee, and
  - (ii) the obligation to make further advances,to be entered on the register of the title to that Real Property in respect of the Security created by paragraph (a)(i) and, if requested by the Security Trustee (and to the extent practicable), paragraph (a)(ii) of Clause 2.1 (*Creation of Security Interests*),
- (d) promptly pay all applicable registration fees, and
- (e) promptly deal with any requisitions by the Land Registry relating to that Real Property and keep the Security Trustee informed as to the progress of any such application for registration, the nature of any such requisitions and its response,

or, if the Security Trustee gives notice to the Chargor that the Security Trustee will submit the relevant forms to the Land Registry, the Chargor shall promptly provide the Security Trustee with all duly completed forms reasonably requested by the Security Trustee and all applicable registration fees

### **5.4 Future Real Property**

If the Chargor acquires any Real Property in England and Wales after the date of this Deed, it shall

- (a) promptly apply to the Land Registry for first registration of that Real Property (where that Real Property is not already registered at the Land Registry) and for registration of it as proprietor of that Real Property,
- (b) promptly upon request by the Security Trustee execute and deliver to the Security Trustee a legal mortgage of that Real Property as security for the payment of all Secured Liabilities,
- (c) promptly apply to the Land Registry to register the Security created by paragraph (a)(ii) of Clause 2 1 (*Creation of Security Interests*) and any legal mortgage created pursuant to paragraph (b) above,
- (d) promptly apply to the Land Registry requesting
  - (i) a restriction in the form specified by the Security Trustee, and
  - (ii) the obligation to make further advances,
 to be entered on the register of the title to that Real Property in respect of the Security created by paragraph (a)(ii) of Clause 2 1 (*Creation of Security Interests*) and any legal mortgage created pursuant to paragraph (b) above,
- (e) promptly pay all applicable registration fees, and
- (f) promptly deal with any requisitions by the Land Registry relating to that Real Property and keep the Security Trustee informed as to the progress of any such application for registration, the nature of any such requisitions and its response,

or, if the Security Trustee gives notice to the Chargor that the Security Trustee will submit the relevant forms to the Land Registry, the Chargor shall promptly provide the Security Trustee with all duly completed forms reasonably requested by the Security Trustee and all applicable registration fees

#### **5 5 Unregistered Real Property**

In the case of the Chargor's Real Property in England and Wales, both present and future, which is not registered at the Land Registry and is not required by law or this Deed to be so registered, if the title deeds and documents are not deposited with the Security Trustee, the Chargor shall promptly apply to the Land Charges Registry to register

- (a) in respect of all such Real Property owned by it on the date of this Deed, this Deed and the Security created by paragraph (a)(i) and paragraph (a)(ii) of Clause 2 1 (*Creation of Security Interests*), and
- (b) in respect of all such Real Property acquired by it after the date of this Deed, this Deed, the Security created by paragraph (a)(ii) of Clause 2 1 (*Creation of Security Interests*) and any legal mortgage created pursuant to paragraph (b) of Clause 5 4 (*Future Real Property*)

#### **5 6 Title Information Document**

On completion of the registration of any Security Interest pursuant to this Clause 5, the Chargor shall promptly supply to the Security Trustee a certified copy of the relevant Title Information

Document issued by the Land Registry or, as the case may be, Certificate of Registration of Land Charge issued by the Land Charges Registry

**5 7 Power to remedy**

- (a) If the Chargor does not comply with any provision of this Clause 5, the Security Trustee, or any agent, contractor or other person required by the Security Trustee, may take any action reasonably necessary to rectify that default
- (b) The cost and expense of any action referred to in paragraph (a) above shall be borne by the Chargor

**6 Bank Accounts**

**6 1 Restriction on Bank Accounts**

Except as permitted by the Finance Documents, the Chargor shall not have any Bank Accounts other than those listed in Schedule 3 (*Assigned Accounts*) and the Distribution Account

**6 2 Withdrawals**

The Chargor shall not make any withdrawal from any Bank Account except in accordance with Clause 10 (*Project Accounts*) of the Common Terms Agreement or the Account Bank Agreement

**6 3 Documents**

The Chargor shall promptly deliver to the Security Trustee, and the Security Trustee shall be entitled to hold, such documents relating to the Chargor's Bank Accounts as the Security Trustee reasonably requires

**6 4 Notice of assignment**

The Chargor shall on the date of this Deed give notice of the assignment in paragraph (b) of Clause 2 1 (*Creation of Security Interests*) substantially in the form set out in Schedule 6 (*Form of notice of assignment of Assigned Accounts*) (or in such other form as is acceptable to the Security Trustee) and shall use reasonable endeavours to ensure that each recipient of any such notice promptly signs and returns the relevant form of acknowledgement

**7 Receivables**

**7 1 Collection**

The Chargor shall promptly collect all Receivables and shall hold the proceeds of collection on trust for the Secured Creditors

**7 2 Payment into designated Bank Account(s)**

The Chargor shall immediately pay all moneys received or receivable by it from any source (including all proceeds of collection of Receivables) into the relevant Bank Account(s) designated pursuant to Clause 10 (*Project Accounts*) of the Common Terms Agreement

**7 3 Restrictions on dealing with Receivables**

The Chargor shall comply with the restrictions set out in Clause 15 4 (*Disposals*) in the Common Terms Agreement

**7 4 Documents**

The Chargor shall promptly deliver to the Security Trustee, and the Security Trustee shall be entitled to hold, such documents relating to its Receivables as the Security Trustee requires



## **8 Investments**

### **8.1 Notification**

Without limiting the provisions of Clause 15.7 (*No other interests or investments*) of the Common Terms Agreement, the Chargor shall promptly notify the Security Trustee of

- (a) its acquisition of, or agreement to acquire, any Investment, and
- (b) the declaration, payment, receipt, offer or issue of any Related Right in respect of any Investment excluding any cash dividend

### **8.2 Documents**

The Chargor shall

- (a) promptly deliver to the Security Trustee, or as it directs, and the Security Trustee shall be entitled to hold, all certificates and other documents of title or evidence of ownership in relation to its Investments, and
- (b) promptly deliver to the Security Trustee, or as it directs, and the Security Trustee shall be entitled to hold, transfers of the Investments and other documents, each executed in blank, relating to the Investments reasonably required by the Security Trustee

### **8.3 Voting before enforcement**

At any time prior to the occurrence of an Event of Default which is continuing the Chargor shall be entitled to exercise or direct the exercise of the voting and other rights attached to any Investment provided that

- (a) it does so for a purpose not inconsistent with any Finance Document, and
- (b) the exercise of or, as the case may be, the failure to exercise those rights would not have an adverse effect on the value of the relevant Investment or the Security Assets or the ability of the Security Trustee to realise the Security Interests and would not otherwise prejudice the interests of any Secured Creditor under any Finance Document

### **8.4 Voting after enforcement**

At any time while an Event of Default is continuing

- (a) the Security Trustee or the Receiver shall be entitled to exercise or direct the exercise of the voting and other rights attached to any Investment, and
- (b) the Chargor shall comply or procure the compliance with any directions of the Security Trustee or the Receiver in respect of the exercise of those rights and shall promptly execute and/or deliver to the Security Trustee or the Receiver such forms of proxy as it requires with a view to enabling such person as it selects to exercise those rights

### **8.5 Cash dividends before enforcement**

At any time prior to the occurrence of an Event of Default which is continuing the Chargor shall be entitled, subject to the terms of the Common Terms Agreement, to retain any cash dividend deriving from the Investments

#### **8 6 Cash dividends after enforcement**

At any time while an Event of Default is continuing the Chargor shall hold any cash dividend deriving from the Investments received by it on trust for the Secured Creditors and transfer or pay the same immediately to the Security Trustee or as it may direct

#### **8 7 Investments held by nominees of the Chargor**

Except for Investments made in the name of the Account Bank in accordance with the Account Bank Agreement, if any Investment is held in the name of a nominee of the Chargor, the Chargor shall promptly upon request by the Security Trustee deliver to it an irrevocable power of attorney, expressed to be given by way of security and executed as a deed by that nominee That power of attorney shall appoint the Security Trustee, each Receiver and each Delegate, as the attorney of the holder and shall be in such form as the Security Trustee requires

#### **8 8 Communications**

- (a) The Chargor shall promptly upon request by the Security Trustee deliver to it a copy of each circular, notice, report, set of accounts or other document received by it or its nominee relating to any of its Investments which the Security Trustee may require for the performance of its duties hereunder
- (b) The Chargor shall promptly deliver to the Security Trustee a copy of, and comply with, each request for information within its knowledge and which is made under section 793 of the Companies Act 2006 or any similar provision contained in any articles of association or other constitutional document relating to any of its Investments
- (c) If the Chargor does not comply with paragraph (b) above, the Security Trustee may provide any information it has on behalf of the Chargor

#### **8 9 Payment of calls**

The Chargor shall promptly pay all calls or other payments in respect of any of its Investments

- (a) If the Chargor does not comply with paragraph (a) above, the Security Trustee may pay that call or other payment on behalf of the Chargor
- (b) The Chargor shall immediately on request by the Security Trustee reimburse the Security Trustee for any payment made by the Security Trustee under this Clause 8 9

### **9 Intellectual Property**

#### **9 1 Notification**

The Chargor shall promptly notify the Security Trustee of its acquisition of, or agreement to acquire, (by licence or otherwise) any Intellectual Property, and any application by it or on its behalf to register any Intellectual Property

#### **9 2 Documents**

The Chargor shall promptly deliver to the Security Trustee, and the Security Trustee shall be entitled to hold, such documents relating to the Chargor's Intellectual Property as the Security Trustee reasonably requires

### **9.3 Grant**

The Chargor shall not grant any exclusive registered user agreement or exclusive licence in relation to any of its present or future Intellectual Property, if any, other than as required by the Project Documents and in accordance with the Common Terms Agreement

## **10 Agreements**

### **10.1 Documents**

The Chargor shall promptly deliver to the Security Trustee, and the Security Trustee shall be entitled to hold, certified copies of each Agreement and shall promptly deliver such other documents relating to the Agreements as the Security Trustee reasonably requires

### **10.2 Notice of assignment**

The Chargor shall on the date of this Deed give notice of the assignment in paragraph (c) of Clause 2.1 (*Creation of Security Interests*) substantially in the form set out in Schedule 7 (*Form of notice of assignment of Agreements*) (or in such other form as is acceptable to the Security Trustee) and shall use reasonable endeavours to ensure that each recipient of any notice promptly signs and returns the relevant form of acknowledgement

### **10.3 Chargor still liable**

The Chargor shall remain liable to perform all its obligations under each Agreement. Neither the Security Trustee, any Receiver nor any Delegate shall be under any obligation or liability to the Chargor or any other person under or in respect of any Agreement

## **11 Insurances**

### **11.1 Documents**

The Chargor shall promptly upon request by the Security Trustee deliver to it, and the Security Trustee shall be entitled to hold, such contracts and policies of insurance, if any, taken out by or on behalf of the Chargor and the related premium receipts, and such other documents relating to the Chargor's Insurances, as the Security Trustee requires

### **11.2 Notice of assignment**

The Chargor shall on the date of this Deed give notice of the assignment in paragraph (d) of Clause 2.1 (*Creation of Security Interests*) substantially in the form set out in Schedule 8 (*Form of notice of assignment of Insurances*) and shall use reasonable endeavours to ensure that each recipient of any such notice promptly signs and returns the relevant form of acknowledgement

### **11.3 Use of proceeds**

The proceeds of any insurance claim shall be applied in accordance with the provisions of the Common Terms Agreement

## **12 General undertakings**

### **12.1 Information**

The Chargor shall supply to the Security Trustee promptly such information regarding its financial condition, business and operations, its Security Assets and its compliance with this Deed as the Security Trustee may reasonably request

## **12 2 Access**

The Chargor shall permit the Security Trustee and/or any of its representatives (including workmen, surveyors, valuers and other persons) at all reasonable times to view the condition of, and repair, any of its Security Assets

## **12 3 No other prejudicial conduct**

The Chargor shall not do, or permit to be done, anything not otherwise permitted under the Finance Documents which could prejudice the Security Interests

## **13 Representations and warranties**

The Chargor

- (a) makes the representations and warranties set out in Clause [6] (*Representations*) of the Common Terms Agreement to the Security Trustee on the date of this Deed, and
- (b) represents and warrants to the Security Trustee that the accounts listed in Schedule 3 (*Assigned Accounts*) are all of the Bank Accounts in which it has an interest

## **14 Enforcement of security interests**

### **14 1 When enforceable**

The Security Interests shall be immediately enforceable while an Event of Default is continuing

### **14 2 Enforcement action**

At any time after the Security Interests have become enforceable in accordance with Clause 14 1 (*When enforceable*), the Security Trustee may in accordance with the Intercreditor Agreement enforce all or any part of the Security Interests in any manner it sees fit or as directed by the Majority Senior Creditor Instructing Group

### **14 3 Law of Property Act powers**

At any time after the Security Interests have become enforceable in accordance with Clause 14 1 (*When enforceable*), the powers, authorities and discretions conferred by the Law of Property Act on mortgagees, including the power of sale and other powers conferred by section 101 (*Powers incident to estate or interest of mortgagee*) of the Law of Property Act, as varied and extended by this Deed, shall be immediately exercisable

## **15 Law of Property Act**

### **15 1 Section 101**

The power of sale and other powers conferred by section 101 (*Powers incident to estate or interest of mortgagee*) of the Law of Property Act on mortgagees, as varied and extended by this Deed, shall arise (and the Secured Liabilities shall be deemed due and payable for that purpose) on the date of this Deed and shall be exercisable in accordance with Clause 14 3 (*Law of Property Act powers*)

### **15 2 Section 103**

Section 103 (*Regulation of exercise of power of sale*) of the Law of Property Act shall not apply to this Deed

**15 3 Section 93**

Section 93 (*Restriction on consolidation of mortgages*) of the Law of Property Act shall not apply to this Deed

**15 4 Sections 99 and 100**

At any time after the Security Interests have become enforceable, the Security Trustee may make any lease or agreement for lease, accept any surrender of lease and grant any option as it sees fit and without the need to comply with any provision of section 99 (*Leasing powers of mortgagor and mortgagee in possession*) or section 100 (*Powers of mortgagor and mortgagee in possession to accept surrenders of leases*) of the Law of Property Act

**16 Appointment of Receivers and Administrators**

**16 1 Appointment of Receivers**

If

- (a) requested by the Chargor, or
- (b) the Security Interests are enforceable,

without any notice or further notice, the Security Trustee may, by deed or otherwise in writing signed by the Security Trustee or any person authorised for this purpose by the Security Trustee, appoint one or more persons to be a Receiver of all or any part of the Security Assets. The Security Trustee may similarly remove any Receiver and appoint any person instead of any Receiver. If the Security Trustee appoints more than one person as Receiver, the Security Trustee may give those persons power to act either jointly or severally.

**16 2 Appointment of Administrators**

Paragraph 14 of Schedule B1 to the Insolvency Act applies to this Deed and the Security Trustee may appoint an Administrator of the Chargor pursuant to that paragraph.

**16 3 Agent of Chargor**

Any Receiver shall be the agent of the Chargor for all purposes. The Chargor alone shall be responsible for the Receiver's contracts, engagements, acts, omissions and defaults and the Security Trustee shall not incur any liability therefore and shall not be responsible for any misconduct or negligence on the part of any Receiver.

**16 4 Remuneration of Receivers**

The Security Trustee may determine the remuneration of any Receiver and the maximum rate specified in section 109(6) (*Appointment, powers, remuneration and duties of receiver*) of the Law of Property Act shall not apply. The Security Trustee may direct payment of that remuneration out of moneys it receives as Receiver. The Chargor alone shall be liable for the remuneration and all other costs, losses, liabilities and expenses of the Receiver.

**17 Rights and liabilities of Security Trustee and Receivers**

**17 1 Rights of Receivers**

Any Receiver appointed pursuant to Clause 16 (*Appointment of Receivers and Administrators*) shall have

- (a) the rights set out in Schedule 1 (*Rights of Receivers*), and

- (b) the rights, powers, privileges and immunities conferred by law, including
  - (i) in the case of an administrative receiver, the rights, powers, privileges and immunities conferred by the Insolvency Act on administrative receivers duly appointed under the Insolvency Act, and
  - (ii) in all other cases, the rights, powers, privileges and immunities conferred by the Law of Property Act and the Insolvency Act on receivers or receivers and managers

#### 17.2 Rights of Security Trustee

At any time after the Security Interests have become enforceable, to the fullest extent permitted by law, any rights conferred by any Finance Document or by law upon a Receiver may be exercised by the Security Trustee, whether or not the Security Trustee shall have appointed a Receiver of all or any part of the Security Assets

#### 17.3 Delegation

The Security Trustee may delegate in any manner to any person any rights exercisable by the Security Trustee under any Finance Document. Any such delegation may be made upon such terms and conditions (including power to sub-delegate) as the Security Trustee thinks fit and the Security Trustee may pass confidential information to any such delegate

#### 17.4 Financial collateral arrangement

- (a) To the extent that this Deed constitutes a "financial collateral arrangement" (as defined in the Financial Collateral Arrangements (No. 2) Regulations 2003 (the "**Financial Collateral Regulations**")) the Security Trustee shall have the right
  - (i) to use and dispose of any Security Asset which constitutes "financial collateral" (as defined in the Financial Collateral Regulations ("**Financial Collateral**")) in such manner as it sees fit, in which case the Security Trustee shall comply with any requirements of the Financial Collateral Regulations in relation to obtaining "equivalent financial collateral" (as defined in the Financial Collateral Regulations),
  - (ii) to set-off the value of any equivalent financial collateral against, or apply it in discharge of, any Secured Liabilities in accordance with the Financial Collateral Regulations, and
  - (iii) at any time after the Security Interests have become enforceable, to appropriate any Security Asset which constitutes Financial Collateral in such manner as it sees fit in or towards satisfaction of the Secured Liabilities in accordance with the Financial Collateral Regulations
- (b) If the Security Trustee is required to value any equivalent financial collateral or Financial Collateral for the purpose of paragraph (a)(ii) or (a)(iii) above, the value shall be
  - (i) in the case of cash, its face value at the time of appropriation or set-off, and
  - (ii) in the case of financial instruments or other Financial Collateral, their market value at the time of appropriation or set-off as determined (after appropriation) by the Security Trustee by reference to a public index or other applicable generally recognised source or such other process as the Security Trustee may select, including a valuation carried out

by an independent investment bank, firm of accountants or other valuers appointed by the Security Trustee,

as converted, where necessary, into the currency in which the Secured Liabilities are denominated at a market rate of exchange prevailing at the time of appropriation or set-off selected by the Security Trustee. The Parties agree that the methods of valuation set out in this paragraph (b) are commercially reasonable for the purpose of the Financial Collateral Regulations

- (c) The Chargor authorises the Security Trustee to transfer any Security Asset which constitutes Financial Collateral in accordance with the Financial Collateral Regulations, and any such Security Asset shall pass from the Chargor to the Security Trustee by way of outright title transfer, free and clear of any liens, claims, charges or encumbrances or any other interest of the Chargor or any third party. The Security Trustee shall, accordingly, have the right to deal with, lend, dispose of, pledge, charge or otherwise use any Security Asset which constitutes Financial Collateral

#### **17.5 Possession**

- (a) If the Security Trustee, any Receiver or any Delegate takes possession of the Security Assets, it may at any time relinquish possession. Neither the Security Trustee, any Receiver nor any Delegate shall be liable, by reason of viewing or repairing any of the present or future assets of the Chargor, as a mortgagee in possession
- (b) The Security Trustee will not, by reason of the creation of the Security, be or be deemed to be a mortgagee in possession

#### **17.6 Security Trustee's liability**

Neither the Security Trustee, any Receiver nor any Delegate shall, either by reason of taking possession of the Security Assets or for any other reason and whether as mortgagee in possession or otherwise, be liable for

- (a) any costs, losses, liabilities or expenses relating to the realisation of any Security Assets, or
- (b) any act or omission of the Security Trustee, any Receiver, any Delegate or their respective officers, employees or agents in relation to the Security Assets or in connection with the Finance Documents, unless directly caused by its gross negligence or wilful misconduct

#### **18 Order of application**

All amounts received or recovered by the Security Trustee or any Receiver pursuant to the terms of this Deed or in connection with the realisation or enforcement of all or any part of the Security Interests shall be held by the Security Trustee on trust and applied, subject to the rights of any creditors having priority, in the order provided in Clause 9 (*Proceeds of Enforcement of Security*) of the Intercreditor Agreement

## **19 Power of attorney**

### **19.1 Appointment**

The Chargor by way of security irrevocably appoints the Security Trustee, each Receiver and each Delegate severally to be its attorney (with full power of substitution), on its behalf and in its name or otherwise, at such time and in such manner as the attorney thinks fit

- (a) to do anything which the Chargor is obliged to do under any Finance Document to which it is party but has failed to do (including to do all such acts or execute all such documents, assignments, transfers, mortgages, charges, notices, instructions, filings and registrations as the Security Trustee may reasonably specify (and in such form as the Security Trustee may reasonably require in favour of the Security Trustee or its nominee(s))), and
- (b) to exercise any of the rights conferred on the Security Trustee, any Receiver or any Delegate in relation to the Security Assets or under any Finance Document or under any law

### **19.2 Ratification**

The Chargor ratifies and confirms and agrees to ratify and confirm whatever any such attorney shall do in the exercise or purported exercise of the power of attorney granted by it in Clause 19.1 (*Appointment*)

## **20 Protection of third parties**

No purchaser or other person dealing with the Security Trustee, any Receiver or its agents shall be concerned to enquire

- (a) whether the powers conferred on the Security Trustee, any Receiver or its agents have arisen,
- (b) whether the powers conferred on the Security Trustee, any Receiver or its agents have become exercisable,
- (c) whether any consents, regulations, restrictions or directions relating to such powers have been obtained or complied with,
- (d) whether the Security Trustee, any Receiver or its agents is acting within such powers,
- (e) whether any money remains due under the Finance Documents and the receipt in writing of the Security Trustee, any Receiver or its agents shall be sufficient discharge to that purchaser or other person,
- (f) as to the propriety or validity of acts purporting or intended to be in exercise of any such powers, or
- (g) as to the application of any money paid to the Security Trustee, any Receiver or its agents



## **21 Saving provisions**

### **21 1 Continuing Security**

Subject to Clause 22 (*Discharge of Security*), the Security Interests are continuing Security and will extend to the ultimate balance of the Secured Liabilities, regardless of any intermediate payment or discharge in whole or in part

### **21 2 Reinstatement**

If any discharge, release or arrangement (whether in respect of the obligations of the Chargor or HoldCo or any security for those obligations or otherwise) is made by a Secured Creditor in whole or in part on the basis of any payment, security or other disposition which is avoided or must be restored in insolvency, liquidation or otherwise, without limitation, then the liability of the Chargor and HoldCo and the Security Interests will continue or be reinstated as if the discharge, release or arrangement had not occurred

### **21 3 Waiver of defences**

Neither the obligations of the Chargor under this Deed nor the Security Interests will be affected by an act, omission, matter or thing which, but for this Clause, would reduce, release or prejudice any of its obligations under any Finance Document or any of the Security Interests (without limitation and whether or not known to it or any Secured Creditor) including

- (a) any time, waiver or consent granted to, or composition with, the Chargor, HoldCo or any other person,
- (b) the release of the Chargor, HoldCo or any other person under the terms of any composition or arrangement with any creditor,
- (c) the taking, variation, compromise, exchange, renewal or release of, or refusal or neglect to perfect, take up or enforce, any rights against, or security over assets of, the Chargor, the other Obligor or any other person or any non-presentation or non-observance of any formality or other requirement in respect of any instrument or any failure to realise the full value of any security,
- (d) any incapacity or lack of power, authority or legal personality of or dissolution or change in the members or status of the Chargor, HoldCo or any other person,
- (e) any amendment, novation, supplement, extension, restatement (however fundamental and whether or not more onerous) or replacement of any Finance Document or any other document or security including any change in the purpose of, any extension of or any increase in any facility or the addition of any new facility under any Finance Document or other document or security,
- (f) any unenforceability, illegality or invalidity of any obligation of any person under any Finance Document or any other document or security, or
- (g) any insolvency or similar proceedings

### **21 4 Chargor intent**

Without prejudice to the generality of Clause 21 3 (*Waiver of defences*), the Chargor expressly confirms that it intends that the Security Interests shall extend from time to time to any (however

fundamental) variation, increase, extension or addition of or to any of the Finance Documents and/or any facility or amount made available under any of the Finance Documents for the purposes of or in connection with the Project or any of the following business acquisitions of any nature, increasing working capital, enabling investor distributions to be made, carrying out restructurings, refinancing existing facilities, refinancing any other indebtedness, making facilities available to new borrowers, any other variation or extension of the purposes for which any such facility or amount might be made available from time to time, and any fees, costs and/or expenses associated with any of the foregoing

**21.5 Immediate recourse**

The Chargor waives any right it may have of first requiring any Secured Creditor (or any trustee or agent on its behalf) to proceed against or enforce any other rights or security or claim payment from any person before claiming from the Chargor under this Deed. This waiver applies irrespective of any law or any provision of a Finance Document to the contrary.

**21.6 Appropriations**

Until the Secured Liabilities have been irrevocably paid in full and all facilities which might give rise to Secured Liabilities have terminated, each Secured Creditor (or any trustee or agent on its behalf) may

- (a) refrain from applying or enforcing any other moneys, security or rights held or received by that Secured Creditor (or any trustee or agent on its behalf) in respect of those amounts, or apply and enforce the same in such manner and order as it sees fit (whether against those amounts or otherwise) and the Chargor shall not be entitled to the benefit of the same, and
- (b) hold in an interest-bearing suspense account any moneys received from the Chargor or on account of the Chargor's liability under this Deed.

**21.7 Deferral of Chargor's rights**

Until the Secured Liabilities have been irrevocably paid in full and all facilities which might give rise to Secured Liabilities have terminated and unless the Security Trustee otherwise directs, the Chargor will not exercise any rights which it may have by reason of performance by it of its obligations under the Finance Documents or by reason of any amount being payable, or liability arising, under the Finance Documents

- (a) to be indemnified by HoldCo,
- (b) to claim any contribution from any other provider of Security for or guarantor of any Obligor's obligations under the Finance Documents,
- (c) to take the benefit (in whole or in part and whether by way of subrogation or otherwise) of any rights of the Secured Creditors under the Finance Documents or of any other guarantee or security taken pursuant to, or in connection with, the Finance Documents by any Secured Creditor,
- (d) to bring legal or other proceedings for an order requiring the other Obligor to make any payment, or perform any obligation, in respect of which such Obligor had given a guarantee, undertaking or indemnity,

- (e) to exercise any right of set-off against HoldCo, and/or
- (f) to claim or prove as a creditor of HoldCo in competition with any Secured Creditor

If the Chargor receives any benefit, payment or distribution in relation to such rights it shall hold that benefit, payment or distribution to the extent necessary to enable all amounts which may be or become payable to the Secured Creditors by HoldCo or the Chargor under or in connection with the Finance Documents to be repaid in full on trust for the Secured Creditors and shall promptly pay or transfer the same to the Security Trustee or as the Security Trustee may direct for application in accordance with Clause 18 (*Order of application*)

#### **21 8 Additional security**

The Security Interests are in addition to and are not in any way prejudiced by any other guarantee or security now or subsequently held by any Secured Creditor

#### **21 9 Tacking**

Each Secured Creditor shall comply with its obligations under the Finance Documents (including any obligation to make further advances)

### **22 Discharge of Security**

#### **22 1 Final redemption**

Subject to Clause 22 2 (*Retention of security*), if the Security Trustee is satisfied that all amounts which may be or become payable by the Obligors under or in connection with the Finance Documents have been irrevocably paid in full and that all facilities which might give rise to Secured Liabilities have terminated, the Security Trustee shall at the request and cost of the Chargor release, reassign or discharge (as appropriate) the Security Assets from the Security Interests, without recourse to, or any representation or warranty by, the Security Trustee or any of its nominees

#### **22 2 Retention of security**

If the Security Trustee considers that any amount paid or credited to any Secured Creditors under any Finance Document is capable of being avoided or otherwise set aside, that amount shall not be considered to have been paid for the purposes of determining whether all the Secured Liabilities have been irrevocably paid

### **23 Costs and expenses**

#### **23 1 Expenses**

The Chargor shall, within five Business Days of demand, pay to the Security Trustee the amount of all costs, losses, liabilities and expenses (including legal fees) incurred by the Security Trustee or any Receiver in relation to any Finance Document (including the administration, protection, realisation, enforcement or preservation of any rights under or in connection with this Deed, or any consideration by the Security Trustee as to whether to realise or enforce the same, and/or any amendment, waiver, consent or release of any Finance Document and/or any other document referred to in this Deed)

**23 2 VAT**

Clause 25 7 (VAT) of the Common Terms Agreement shall apply as if it were set out in full in this Deed, save that references in that Clause to "Finance Party" shall be treated in this Deed as being to "Secured Creditor, Receiver or Delegate"

**24 Indemnity**

The Chargor shall, within five Business Days of demand, indemnify the Security Trustee and any Receiver against any cost, loss, liability or expense properly incurred by it or them as a result of

- (a) any breach by the Chargor of this Deed, or
- (b) the exercise or purported exercise of any of the rights, powers, discretions, authorities and remedies conferred on it or them by this Deed or otherwise relating to the Security Assets

**25 Payments**

**25 1 Undertaking to pay**

The Chargor shall pay each of the Secured Liabilities when due in accordance with its terms

**25 2 Demands**

Any demand for payment made by any Secured Creditor, to the extent that any of the Secured Liabilities referred to therein are due and payable, shall be valid and effective even if it contains no statement of the relevant Secured Liabilities or an inaccurate or incomplete statement of them

**26 Payments**

All payments by the Chargor under this Deed shall be made to such account, with such financial institution and in such other manner as the Security Trustee may direct

**26 1 Continuation of accounts**

- (a) At any time after a Secured Creditor has received or is deemed to have received notice of any subsequent Security affecting all or any part of the Security Assets of the Chargor, that Secured Creditor may open a new account in the name of the Chargor (whether or not it permits any existing account to continue)
- (b) If that Secured Creditor does not open such a new account, it shall be treated as if it had done so when the relevant notice was received or deemed to have been received and as from that time all payments made by or on behalf of the Chargor to that Secured Creditor shall be credited or be treated as having been credited to the relevant new account and not as having been applied in reduction of the Secured Liabilities as at the time the relevant notice was received or deemed to have been received

**26 2 Contingencies**

If all or any part of the Security Interests are enforced at a time when no amount is due under the Finance Documents but any such amount may or will become due, the Security Trustee or the Receiver may pay the proceeds of any recoveries effected by it into a suspense account

## **27 Remedies, waivers and determinations**

### **27.1 Remedies and waivers**

No failure to exercise, nor any delay in exercising, on the part of any Secured Creditor, Receiver or Delegate, any right or remedy under any Finance Document shall operate as a waiver of any such right or remedy or constitute an election to affirm any of the Finance Documents. No waiver or election to affirm any of the Finance Documents on the part of any Secured Creditor, Receiver or Delegate shall be effective unless in writing. No single or partial exercise of any right or remedy shall prevent any further or other exercise or the exercise of any other right or remedy. The rights and remedies provided in the Finance Documents are cumulative and not exclusive of any rights or remedies provided by law, including the right to appoint an Administrator under the Insolvency Act.

### **27.2 Certificates and determinations**

Any certification or determination by the Security Trustee or any Receiver of a rate or amount under any Finance Document is, in the absence of manifest error, conclusive evidence of the matters to which it relates.

## **28 Separate and independent obligations**

The Security created by the Chargor by or in connection with any Finance Document is separate from and independent of the Security created or intended to be created by HoldCo or any other provider of Security by or in connection with any Finance Document.

## **29 Counterparts**

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

## **30 Governing law**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

## **31 Enforcement**

- (a) The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute relating to the existence, validity or termination of this Deed or any non-contractual obligation arising out of or in connection with this Deed) (a "**Dispute**").
- (b) The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
- (c) This Clause 31 is for the benefit of the Security Trustee only. As a result, the Security Trustee shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Security Trustee may take concurrent proceedings in any number of jurisdictions.

(f) **Hive down**

to form a new company and to subscribe for or acquire (for cash or otherwise) any investment in or of the new company and to sell, transfer, assign, exchange and otherwise dispose of or realise any such investments or any rights attaching thereto,

(g) **Borrow money**

to borrow or raise money either unsecured or on the security of all or any part of the Security Assets (either in priority to the Security Interests or otherwise),

(h) **Lend money**

to lend money or advance credit to any person,

(i) **Covenants and guarantees**

to enter into bonds, covenants, guarantees, indemnities and other commitments,

(j) **Dealings with tenants**

to grant leases, tenancies, licences and rights of user, grant renewals and accept surrenders of leases, tenancies, licences or rights of user, and otherwise to reach agreements and make arrangements with, and to make allowances to, any lessees, tenants or other persons,

(k) **Rights of ownership**

to manage and use all or any part of the Security Assets and to exercise and do all such rights and things as the Receiver would be capable of exercising or doing if it were the absolute beneficial owner of all or any part of the Security Assets,

(l) **Protection of Security Assets**


