Summary of Activities

During the year from November 2021 to October 2022, North Devon Moving Image CIC (NDMI) worked with people of all ages and abilities from the communities of North Devon and around the UK to produce short films that inspire, enlighten, and entertain.

Through our local heritage and community projects we have enabled contributors and participants to develop technical and personal skills, connect with local heritage and the natural environment, learn about the lives of others, and have their voices heard. The viewers of the films we produced have been able to learn about people, places, then environment, and history of North Devon.

2022 was a busy year at NDMI, with some ambitious projects undertaken.

Red Bull: The year began with a huge win for NDMI, as we secured a film with Andrew Cotton and Andrew Blake for Red Bull UK. Both Andrews are North Devon locals: Cotty is a Red Bull Athlete and Big Wave Surfer, and Blakey is his personal trainer, as well as working with England Rugby. This film was all about the breathing techniques Blakey guides Cotty through in order to help him deal with stress and manage life-threatening situations when surfing the world's biggest waves. NDMI interviewed both Andrews and spent the day down in Exmouth with Blakey running through some breathing techniques and cold-water immersion with the Exeter Chiefs Women's Rugby Team.

North Devon World Surfing Reserve: 2022 was a big year for surf news in North Devon, and NDMI were lucky to be involved in breaking the biggest surf news our community has ever had. North Devon received World Surfing Reserve status in March 2022 and NDMI was asked to film a series of shorts for the North Devon World Surfing Reserve's social media channels to help clarify what this new status means for surfing in the area. We interviewed members of the NDWSR core team at the Museum of British Surfing and our films were shared widely across social media.

One Northern Devon Health Inequalities: NDMI was approached by One Northern Devon to make a film to support their research into Health Inequalities in North Devon. They had commissioned a study to explore what the main health struggles North Devon residents experienced and identify ways of improving the situation for locals. For this film, NDMI partnered up with Encompass Southwest again to interview some of their most vulnerable residents. We met Millie and told the story of her personal health struggles and the difficulties she faced with her particular health issues. It was a very powerful and moving story. One of many that needed to be told.

Three Lakes Challenge: Building on the success of our Red Bull film, Cotty returned for more with a new concept as part of his ambassadorial role for boot brand, XTRATUF. He'd set himself the XTRATUF challenge of travelling to and swimming in the UK's three highest lakes in only a couple of days. Not only was it extra tough for Cotty, it was extra tough for NDMI, lugging all the kit up and down mountains in all sort of horrendous weather conditions. However, the result was pretty epic, showcasing some of the UK's most stunning landscapes. Sadly, Cotty didn't make it to the last lake because of the treacherous weather. Might this open up the opportunity for another XTRATUF challenge in the future?

Wahine Summer Slide: Wave Wahines is a girls' surf group, empowering women in North Devon through surf. NDMI was invited to film their Summer Slide; an open event for women surfers to compete, have fun, and socialise. It was brilliant to see women of all ages having a thoroughly enjoyable and relaxed couple of days on the beach, with some epic surfing thrown in for good measure.

Lundy Marine Festival: Perhaps NDMI's most ambitious project to date, the Lundy Marine Festival approached us to film a documentary commemorating 50 Years of the No Take Zone at Lundy Island, in collaboration with Blue Marine Foundation. We took this as an opportunity to offer a week's work experience for 8 Ilfracombe Young Filmmakers, camping and filming on Lundy during the first big heatwave of July 2022. It was an amazing experience for all and the footage we gathered was, at times, magical. This project is still ongoing into 2023, as further interviews and results of the studies on Lundy need to be filmed, as well as a further visit to the island to film the return of the migratory birds. The documentary is slated for release Summer 2023.
