THE DIRECTORS MAY DECLARE AND PAY DIVIDENDS ON THE ORDINARY SHARES. EACH ORDINARY SHARE SHALL RANK EQUALLY WITH ALL OTHER ORDINARY SHARES IN THE CAPITAL OF THE COMPANY FOR ANY DIVIDEND AND SHALL RECEIVE ITS PRO RATA PORTION OF ANY DIVIDEND. C. ON A RETURN OF CAPITAL ON LIQUIDATION, REDUCTION OF CAPITAL OR OTHERWISE, THE SURPLUS ASSETS OF THE COMPANY AVAILABLE FOR DISTRIBUTION AMONG THE MEMBERS SHALL BE APPLIED IN THE SAME ORDER OF PRIORITY AS APPLIES IN RESPECT OF DIVIDENDS AND DISTRIBUTIONS. THE DIRECTORS MAY DECLARE AND PAY DIVIDENDS ON THE PREFERENCE SHARES. A CUMULATIVE, PREFERENTIAL DIVIDEND AT THE RATE OF 13 PER CENT. PER ANNUM OF THE SUBSCRIPTION PRICE SHALL ACCRUE ON EACH PREFERENCE SHARE ON A DAILY BASIS AND COMPOUND ANNUALLY (ON THE ASSUMPTION OF A 365 DAY PER YEAR BASIS) ON 12 DECEMBER EACH YEAR FROM THE DATE OF ISSUE OF SUCH PREFERENCE SHARES WHETHER OR NOT THERE ARE SUFFICIENT DISTRIBUTABLE RESERVES LEGALLY AVAILABLE TO THE COMPANY TO PERMIT PAYMENT. C. ON A RETURN OF CAPITAL ON LIQUIDATION, REDUCTION OF CAPITAL OR OTHERWISE, THE SURPLUS ASSETS OF THE COMPANY AVAILABLE FOR DISTRIBUTION AMONG THE MEMBERS SHALL BE APPLIED IN THE SAME ORDER OF PRIORITY AS APPLIES IN RESPECT OF DIVIDENDS AND DISTRIBUTIONS. D. THE PREFERENCE SHARES ARE REDEEMABLE.
