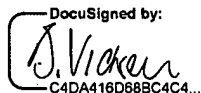

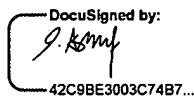

#### **1. GENERAL INFORMATION**

Braeburn Estates (B3) T1 Limited is a Company Limited by shares incorporated in the UK under the Companies Act 2006 and registered in England and Wales at One Canada Square, Canary Wharf, London, E14 5AB.

The nature of the company's operations and its principal activities are set out in the Directors' Report.

##### **2.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS**
