ORDER

UPON the application of Sukhvinder Kaur Bains (the “**Application**”)

AND UPON reading the witness statements of Sukhvinder Kaur Bains, Lauren Louise Auburn, Thomas Edward Guthrie and John William Rimmer

IT IS ORDERED THAT:

1. The Applicant, Sukhvinder Kaur Bains, is removed from her office as Liquidator in respect of the companies in Creditors’ Voluntary Liquidation which are set out in Schedule A attached hereto.
 2. The Respondents, Lauren Louise Auburn, Thomas Edward Guthrie and John William Rimmer, are appointed as Liquidator in substitution of the Applicant in respect of the companies which are set out in Schedule A attached hereto where they are identified as proposed appointee.
 3. The Applicant, Sukhvinder Kaur Bains, is removed from her office as Liquidator in respect of the limited liability partnership in Creditors’ Voluntary Liquidation which is set out in Schedule B attached hereto.

4. The First Respondent, Lauren Louise Auburn, is appointed as Liquidator in substitution of the Applicant in respect of the limited liability partnership which is set out in Schedule B attached hereto.
 5. The Applicant, Sukhvinder Kaur Bains, is removed from her office as Liquidator in respect of the companies in Members' Voluntary Liquidation which are set out in Schedule C attached hereto.
 6. The Respondents, Lauren Louise Auburn, Thomas Edward Guthrie and John William Rimmer, are appointed as Liquidator in substitution of the Applicant in respect of the companies which are set out in Schedule C attached hereto where they are identified as proposed appointee.
 7. The Applicant shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, a block advertisement in respect of each of the insolvency appointments listed in Schedules A, B and C shall be placed in the London Gazette containing notification of the following matters:
 - 7.1 the removal of the Applicant and the substitution of the Applicant by one of the Respondents, as the case may be;
 - 7.2 that creditors (and members in the case of Members' Voluntary Liquidations) and debtors have liberty to apply within 28 days after the notice has been advertised, to object to the Applicant's release; and
 - 7.3 that in the case of the Liquidations listed in Schedules A, B and C, the Applicant will be entitled to apply to the Secretary of State for her release upon the expiry of 42 days from the date the notice has been advertised, save that in the event of an application in relation to one of the insolvency appointments has been made by a creditor, a member in the case of Members' Voluntary Liquidations, or a debtor, within the relevant time period, objecting to the said release, the Applicant will not seek to apply for her release in relation to that insolvency appointment until after the said application has been disposed of (whether by agreement or by order of the Court).
 8. In relation to the insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency (England and Wales) Rules 2016 contain any requirement for advertisement of the removal of the Applicant or her substitution by the Respondents, compliance with paragraph 7 above shall be deemed as being sufficient compliance with any such advertisement provisions and for the avoidance of doubt, any further compliance with such notice provisions shall be waived. Insofar as the Applicant is required by law to give any notice of her removal from office, the Respondents are entitled to sign and send any such notice on her behalf.
 9. The period to be covered by progress reports to members and/or creditors and the dates by which those reports need to be sent to members and/or creditors and filed with the Registrar of Companies (if applicable) shall not be altered by virtue of the making of this Order or the replacement of the Applicant by the Respondents, pursuant to this Order; and for the avoidance of doubt, any such requirement necessitating an alteration
-

in the reporting dates by reason of the commencement, termination or replacement of an office-holder's appointment, are hereby waived.

10. In each of the Liquidations listed in Schedules A, B and C, the Applicant shall be at liberty to apply to the Secretary of State for her release upon the expiry of 42 days from the date when the relevant notice referred to in paragraph 7 has been placed in the London Gazette, save that in the event of an application in relation to one of the insolvency appointments has been made by a creditor, a member in the case of Members' Voluntary Liquidations, or a debtor, within the relevant time period, objecting to the said release, the Applicant will not seek to apply for her release in relation to that insolvency appointment until after the said application has been disposed of (whether by agreement or by order of the Court).
11. The costs of and occasioned by the Application shall be paid by BRI Business Recovery and Insolvency.
12. There be liberty to apply.
