ORDER

UPON THE APPLICATION OF Martin Richard Buttriss dated 20 August 2019

**AND UPON READING the witness statement of Martin Richard Buttriss dated 9 August
2019:-**

IT IS ORDERED THAT:

- 1. The insolvency proceedings listed in the Schedules to this Order which are not currently before the High Court of Justice be transferred to the High Court of Justice for the purposes of this application only, and the Applicant do ensure that a sealed copy of this Order be lodged with the Court having jurisdiction over each case affected by the Order.**
- 2. The Applicant, Martin Richard Buttriss, be removed from his office as Liquidator in respect of the companies in Members' Voluntary Liquidation which are set out in Schedule A hereto with immediate effect.**
- 3. The Applicant, Martin Richard Buttriss, be removed from his office as Liquidator in respect of the companies in Creditors' Voluntary Liquidation which are set out in Schedule B hereto with immediate effect.**

4. The Applicant, Martin Richard Buttriss, be removed from his office as Liquidator in respect of the companies in Compulsory Liquidation which are set out in Schedule C hereto with immediate effect.
5. The Applicant, Martin Richard Buttriss, be removed from his office as Administrator in respect of the companies in Administration which are set out in Schedule D hereto with immediate effect.
6. The Applicant, Martin Richard Buttriss, be removed from his office as Supervisor in respect of the companies in Company Voluntary Arrangements which are set out in Schedule E hereto with immediate effect.
7. The Applicant, Martin Richard Buttriss, be removed from his office as Supervisor in respect of the individuals in Individual Voluntary Arrangements which are set out in Schedule F hereto with immediate effect.
8. In relation to each of the insolvency proceedings listed in the Schedules to this Order, the Respondent shall procure that, as soon as reasonably practicable, and in any event within 21 days of the date of the Order, a block advertisement shall be placed in the London Gazette containing notification of the removal of the Applicant and of the matters in paragraphs 9 and 10 of this Order.
9. The creditors, members (in the case of Members' Voluntary Liquidations) and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have liberty to apply, within 21 days after the notice has been advertised, to vary or set aside the order made.
10. The creditors, members (in the case of Members' Voluntary Liquidations) and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have the right to object and make representations to the Applicant in respect of the Applicant's release within 21 days after the notice has been advertised.
11. In relation to each of the insolvency proceedings listed in the Schedules to this Order where the Applicant is required under the Insolvency Act 1986 or the Insolvency (England and Wales) Rules 2016 to apply for his release, the Applicant may apply to the Secretary of State for his release upon expiry of 21 days from the date the notice referred to in paragraph 8 of this Order has been placed in the London Gazette. In relation to the Schedule D administrations, the Applicant shall be released 21 days from the date of the said notice.
12. In relation to the insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency (England and Wales) Rules 2016 contain any requirement for advertisement of the removal of the Applicant, the requirement shall be dispensed with save to the extent provided for herein.
13. The Respondent shall give notice to the Secretary of State, and to the Registrar of Companies in respect of the companies which are set out in Schedules to this Order, of the terms of this Order as soon as reasonably practicable.
14. Insofar as the Applicant is required by law to give any notice of the removal from office, the Respondent is entitled to sign and send any such notice on his behalf.
15. There be no order as to costs.
16. There be liberty to apply.
