INTERPRETATION

2 In these articles

"the articles" means the Charity's articles of association,

"the Charity" means the company intended to be regulated by the articles,

"clear days" in relation to the period of a notice means a period excluding

- the day when the notice is given or deemed to be given, and
- the day for which it is given or on which it is to take effect,

"the Commission" means the Charity Commissioners for England and Wales,

"Companies Acts" means the Companies Acts as defined in section 2 of the Companies Act 2006(insofar as they apply to the Charity,

"the Directors" means the directors of the Charity. The directors are charity trustees as defined by section 97 of the Charities Act 1993,

"document" includes, unless otherwise specified, any document sent or supplied in electronic form,

"electronic form" has the meaning given is section 1168 of the Companies Act 2006,

"the memorandum" means the memorandum of association of the Charity,

"officers" includes the Directors and the secretary (if any),

"the seal" means the common seal of the Charity if it has one,

"secretary" means any person appointed to perform the duties of the secretary of the Charity,

"the United Kingdom" means Great Britain and Northern Ireland,

and words importing one gender shall include all genders, and the singular includes the plural and vice versa

Unless the context otherwise requires words or expressions contained in these articles have the same meaning as in the Companies Acts but excluding any statutory modification not in force when this constitution becomes binding on the Charity

Apart from the exception mentioned in the previous paragraph a reference to an Act of Parliament includes any statutory modification or reenactment of it for the time being in force

LIABILITY OF MEMBERS

3 (1) The liability of the members is limited

(2) Every member promises, if the Charity is dissolved while he or she or it is a member or within twelve months after he or she or it ceases to be a member, to contribute such sum (not exceeding £10) as may be demanded of him or her towards the payment of the debts and liabilities of the Charity incurred before he or she or it ceases to be a member, and of the costs, charges and expenses of winding up, and the adjustment of the rights of the contributories among themselves

OBJECTS

٦

- 4 The Charity's objects ("Objects") are specifically restricted to the following
 - To assist in the treatment and care of persons suffering from mental or physical illness of any description or in need of rehabilitation as a result of such illness, by the provision of health care resources, information, advice and guidance
 - The relief and assistance of people in the horn or Africa who are the victims of war or natural disaster, trouble, or catastrophe in particular by the supply of medical aid, shelter and food to such persons
 - The prevention or relief of poverty by providing or assisting in the provision of education, training, healthcare projects and all the necessary support designed to enable individuals to generate a sustainable income and be self-sufficient

POWERS

- The Charity has the power to do anything which is calculated to further its Object(s) or is conducive or incidental to doing so. In particular, the Charity has the power
 - (a) to raise funds. In doing so, the Charity must not undertake any substantial permanent trading activity and must comply with any relevant statutory regulations,
 - (b) to buy, take on lease or in exchange, hire or otherwise acquire any property and to maintain and equip it for use,
 - to sell, lease or otherwise dispose of all or any part of the property belonging to the Charity. In exercising this power, the Charity must comply as appropriate with sections 36 and 37 of the Charities Act 1993 as amended by the Charities Act 2006.
 - (d) to borrow money and to charge the whole or any part of the property belonging to the Charity as security for repayment of the money borrowed or as security for a grant or the discharge of an obligation. The Charity must comply as appropriate with sections 38 and 39 of the Charities Act 1993, as amended by the Charities Act 2006, if it wishes to mortgage land,
 - (e) to co-operate with other charities, voluntary bodies and statutory authorities and to exchange information and advice with them,
 - (f) to establish or support any charitable trusts, associations or institutions formed for any of the charitable purposes included in the Objects,

- (g) to acquire, merge with or to enter into any partnership or joint venture arrangement with any other charity,
- (h) to set aside income as a reserve against future expenditure but only in accordance with a written policy about reserves.
- (i) to employ and remunerate such staff as are necessary for carrying out the work of the Charity. The Charity may employ or remunerate a Director only to the extent it is permitted to do so by article 6 and provided it complies with the conditions in that article.
- (j) to
 - (i) deposit or invest funds,
 - (11) employ a professional fund-manager, and
 - (111) arrange for the investments or other property of the Charity to be held in the name of a nominee,

in the same manner and subject to the same conditions as the trustees of a trust are permitted to do by the Trustee Act 2000,

- (k) to provide indemnity insurance for the Directors in accordance with, and subject to the conditions in, section 73F of the Charities Act 1993,
- (I) to pay out of the funds of the Charity the costs of forming and registering the Charity both as a Company and as a charity

APPLICATION OF INCOME AND PROPERTY

- 6 (1) The income and property of the Charity shall be applied solely towards the promotion of the Objects
- (2) (a) A Director is entitled to be reimbursed from the property of the Charity or may pay out of such property reasonable expenses properly incurred by him or her when acting on behalf of the Charity
 - (b) A Director may benefit from trustee indemnity insurance cover purchased at the Charity's expense in accordance with, and subject to the conditions in, section 73F of the Charities Act 1993,
 - (c) A Director may receive an indemnity from the Charity in the circumstances specified in Article 56,
- None of the income or property of the Charity may be paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit to any member of the Charity. This does not prevent a member who is not also a Director receiving
 - (a) a benefit from the Charity in the capacity of a beneficiary of the Charity,
 - (b) reasonable and proper remuneration for any goods or services supplied to the Charity

(4)(A) No Director or connected person may

- (a) buy goods or services from the Charity on terms preferential to those applicable to members of the public,
- (b) sell goods, services or any interest in land to the Charity,
- (c) be employed by or receive any remuneration from the Charity,

Unless

(1) the payment is permitted by 6(4)(B)(a) or

- (ii) the Directors obtain the prior written approval of the Commission and fully comply with any procedures it prescribes
- (4) (B) (a) (a) A Director or connected person may receive a benefit from the Charity in the capacity of a beneficiary of the Charity provided that a majority of the directors do not benefit in this way
 - (ii) A Director or connected person may enter into a contract for the supply of services, or of goods that are supplied in connection with the provision of services, to the Charity where that is permitted in accordance with, and subject to the conditions in, Section 73A to 73C of the Charities Act 1993
 - (iii) Subject to Article 6 (4)(C) a Director or connected person may provide the Charity with goods that are not supplied ion connection with services provided to the Charity by the Director or connected person
 - (iv) A Director or connected person may receive interest on money lent to the Charity at a reasonable and proper rate which must be 2% (or more) per annum below the base rate of a clearing bank to be selected by the Directors
 - (v) A Director may receive rent for premises let by the Director or connected person to the Charity if the amount of the rent and the other terms of the lease are reasonable and proper and provided that such a Director shall withdraw from any meeting at which such a proposal or the rent or other terms of the lease are under discussion
 - (vi) The Directors may arrange for the purchase, out of the funds of the Charity, of insurance designed to indemnify the Directors in accordance with the terms of, and subject to the conditions in, section 73F of the Charities Act 1993
 - (vii) A Director or connected person may take part in the normal trading and fundraising activities of the Charity on the same terms as members of the public
- (4) (C) The Charity and its Directors may only rely upon the authority provided by article 6 (4)(B)(a)(iii) if each of the following conditions is satisfied
 - (a) The amount or the maximum amount of the payment for the goods is set out in an agreement in writing between
 - (i) the Charity or its Directors (as the case may be), and
 - (ii) the Director or connected person supplying the goods ("the supplier") under which the supplier is to supply the goods in question to or on behalf of the Charity
 - (b) The amount or maximum amount of the payment for the goods does not exceed what is reasonable in the circumstances for the supply of the goods in question
 - (c) The other Directors are satisfied that it is in the best interest of the Charity to contract with the supplier rather than with someone who is not a Director or connected person. In reaching that decision the Directors must balance the advantage of contracting with a Director or connected person against the disadvantages of doing so
 - (d) The supplier is absent from the part of any meeting at which there is discussion of the proposal to enter into a contract or arrangement with him or her or it with regard to the supply of goods to the Charity
 - (e) The supplier does not vote on any such matter and is not to be counted when calculating whether a quorum of Directors is present at the meeting
 - (f) The reason for their decision is recorded by the Directors in the minute book
 - (g) A majority of the Directors then in office are not in receipt of remuneration or payments authorised by article 6 (4) (A)
- (5) (a) In sub-clauses (2)-(4) of this article 6 "charity" shall include any company in which the Charity

 - (iv) an institution which is controlled -
 - (I) by the Director or any connected person falling within paragraph (i), (ii), or (iii) above, or
 - (II) by two or more persons falling within sub-paragraph (I), when taken together

 - the Director or any connected person falling within paragraphs (i) to (iii) has a substantial interest, or
 - (II) two or more persons falling within sub-paragraph (I) who, when taken together, have a substantial interest
- (c) Paragraphs 2 to 4 of schedule 5 to the Charities Act 1993 apply for the purposes of interpreting the terms used in this sub-clause

MEMBERS

- 7 (1) The subscribers to the memorandum are the first members of the Charity
- (2) Membership is open to other individuals or organisations who
 - (a) apply to the Charity in the form required by the Directors, and
 - (b) are approved by the Directors
- (3) (a) The Directors may only refuse an application for membership if, acting reasonably and properly, they consider it to be in the best interests of the Charity to refuse the application
 - (b) The Directors must inform the applicant in writing of the reasons for the refusal within twenty-one days of the decision
 - (c) The Directors must consider any written representations the applicant may make about the decision. The Directors' decision following any written representations must be notified to the applicant in writing but shall be final
- (4) Membership is not transferable to anyone else
- (5) The Directors must keep a register of names and addresses of the members

CLASSES OF MEMBERSHIP

- 8 (1) The Directors may establish classes of membership with different rights and obligations and shall record the rights and obligations in the register of members
- (2) The Directors may not directly or indirectly alter the rights or obligations attached to a class of membership
 - (3) The rights attached to a class of membership may only be varied if
 - (a) three-quarters of the members of that class consent in writing to the variation, or

- (b) a special resolution is passed at a separate general meeting of the members of that class agreeing to the variation
- (4) The provisions in these articles about general meetings shall apply to any meeting relating to the variation of the rights of any class of members

TERMINATION OF MEMBERSHIP

- 9 Membership is terminated if
- (1) the member dies or, if it is an organisation, ceases to exist,
- (2) the member resigns by written notice to the Charity unless, after the resignation, there would be less than two members,
- (3) any sum due from the member to the Charity is not paid in full within six months of it falling due,
- (4) the member is removed from membership by a resolution of the Directors that it is in the best interests of the Charity that his or her membership is terminated. A resolution to remove a member from membership may only be passed if
 - (a) the member has been given at least twenty-one days' notice in writing of the meeting of the Directors at which the resolution will be proposed and the reasons why it is to be proposed,
 - (b) the member or, at the option of the member, the member's representative (who need not be a member of the Charity) has been allowed to make representations to the meeting

GENERAL MEETINGS

- 10 (1) The Charity must hold its first annual general meeting within eighteen months after the date of its incorporation
 - (2) An annual general meeting must be held in each subsequent year and not more than fifteen months may clapse between successive annual general meetings
- 11 The Directors may call an extraordinary general meeting at any time

NOTICE OF GENERAL MEETINGS

- 12 (1) The minimum periods of notice required to hold a general meeting of the Charity are
 - (a) twenty-one clear days for an annual general meeting or a general meeting called for the passing of a special resolution,
 - (b) fourteen clear days for all other extraordinary general meetings
- (2) A general meeting may be called by shorter notice if it is so agreed by a majority in number of members having a right to attend and vote at the meeting, being a majority who together hold not less than 90% of the total voting rights
- The notice must specify the date, time and place of the meeting and the general nature of the business to be transacted. If the meeting is to be an annual general meeting, the notice must say so. The notice must also contain a statement setting out the right of members to appoint a proxy under section 324 of the Companies Act 2006 and article 19.
- (4) The notice must be given to all the members and to the Directors and auditors
- The proceedings at a meeting shall not be invalidated because a person who was entitled to receive notice of the meeting did not receive it because of an accidental omission by the Charity

 - (c) is signed by or on behalf of the member appointing the proxy, or is authenticated in such manner as the Directors may determine, and
 - (d) is delivered to the Charity in accordance with the articles and any instructions contained in the notice of the general meeting to which they relate
- (2) the Charity may require proxy notices to be delivered in a particular form, and may specify different forms for different purposes
- (3) Proxy notices may specify how the proxy appointed under them is to vote (or that the proxy is to abstain from voting) on one or more resolutions
- (4) Unless a proxy notice indicates otherwise, it may be treated as -
 - (a) allowing the person appointed under it as a proxy discretion as to how to vote on any ancillary or procedural resolutions put to the meeting,

DELIVERY OF PROXY NOTICES

- 19A (1) A person who is entitled to attend, speak or vote (either on a show of hands or on a poll) at a general meeting remains so entitled in respect of that meeting or any adjournment of it, even though a valid proxy notice has been delivered to the Charity by or on behalf of that person

- 57 (1) The Directors may from time to time make such reasonable and proper rules or bye-laws as they may deem necessary or expedient for the proper conduct and management of the Charity

 - (a) the admission of members of the Charity (including the admission of organisations to membership) and the rights and privileges of such members, and the entrance fees, subscriptions and other fees or payments to be made by members,

 - (c) the setting aside of the whole or any part or parts of the Charity's premises at any particular time or times or for any particular purpose or purposes,

 - (e) generally, all such matters as are commonly the subject matter of Company rules
- (3) The Chanty in general meeting has the power to alter, add to or repeal the rules or bye-laws
- (4) The Directors must adopt such means as they think sufficient to bring the rules and bye-laws to the notice of members of the Charity
- (5) The rules or bye-laws, shall be binding on all members of the Charity No rule or bye-law shall be inconsistent with, or shall affect or repeal anything contained in the articles

DISSOLUTION

- (2) Subject to any such resolution of the members of the Charity, the Directors of the Charity may at any time before, and in expectation of, its dissolution resolve that any net assets of the Charity after all its debts and liabilities have been paid, or provision made for them, shall on dissolution of the Charity be applied or transferred

- (b) by transfer to any charity or charities for purposes similar to the Objects, or
- (c) to any charity or charities for use for particular purposes that fall within the Objects
- (3) In no circumstances shall the net assets of the Charity be paid to or distributed among the members of the Charity (except to a member that is itself a charity) and if no resolution in accordance with article 58(1) is passed by the members or the Directors the net assets of the Charity shall be applied for charitable purposes as directed by the Court or the Commission
