

#### NOTES TO THE ESTIMATED STATEMENT OF AFFAIRS

## 1. Assets Specifically Pledged

#### 2. Assets Not Specifically Pledged

#### Debtor (connected)

The book value of the debtor has been provided by the director Nasir Ali Hussain and relates to A2Z Head Office Limited of which Nasir Ali Hussain is also a director. The estimated to realise values has been shown as uncertain for the purposes of the statement of affairs, as A2Z Head Office Limited is considered insolvent and has commenced the process to be placed into insolvent liquidation.

## 3. Employee Claims / ERA'2006 Claims (est.)

Where applicable, the RPS will make payments directly to the employees and then the RPS will then lodge a claim against the Company in respect of the payments it has made. Employee Claims / ERA'2006 have been estimated for the purposes of the statement of affairs and are not considered as agreed amounts.

#### 4. Prescribed Part

As the Company has no unsatisfied post-Enterprise Act charges, there will be no requirement to set aside a prescribed part in this case
