The Elmley Nature Reserve CIC support public access to a family owned and run estate, Elmley, which is a National Nature Reserve and working farm. The CIC does not own the land or facilities. In the financial year 2015-16 the Company has used monies received for the maintenance and improvement of visitor access and facilities, specifically

- Repair of four bird watching hide painting, structural repair to the hides' frames and improvements to the access paths to each
- Repair of access bridges to hides including replacement of footing posts, supporting beams, foot boards and hand rails
- · Construction and maintenance of dry footpaths on the reserve
- Repair of the entry road pothole filing and grading
- Enhancement of a view screen to providing new bird watching opportunities over the Swale Channel
- Maintenance and cleaning of the visitor toilets
- Maintenance of bird feeding stations including provision of year round seed and nuts in the visitor car park
- · Setup and day-to-day running of the Friends of Elmley group,
- The remaining costs have been incurred on administration including website and office costs

The company's stakeholders are the landowners, Natural England, employees working at Elmley and members of the public whom visit Elmley, particularly those who have joined the Friends of Elmley. The directors of the company have owned and worked at Elmley for over forty years. They took on responsibility of visitor management in May 2013 following the departure of a large conservation NGO from the site. Therefore, this company was set up to ensure public access was maintained and improved at Elmley alongside the other activities of land management for conservation, livestock farming, overnight accommodation and events.

The following engagement has taken place

- Meeting with local government officials and stakeholder took place in May 15 and March 16. A general overview of the CIC and future plans was given to attendees Ideas of possible improvements and new funding streams was taken forward.
- Regular verbal discussions, email communications including a monthly newsletter with the 'Friends of Elmley' (circa 350 members)
- Guidance and advice is taken from those who do voluntary work at Elmley
- Consultation with Natural England, the Government agency for wildlife and designated site of wildlife conservation

Feedback on has been overwhelmingly positive regarding the improvements to the walkways, bridges, paths, hides and entry road. Feedback regarding changes to the landscape management by ECT (Conservation) Ltd, the landowner, were noted by engagement with visitors through the CIC and information notices were erected to improve communication of works with visitors over the summer.

Regular volunteers also now work on the nature reserve and act as Elmley ambassadors
