Notes to the Statement of Affairs as at 11 July 2019

1. Furniture & Equipment

Furniture & Equipment owned by the Company was listed in the management accounts to 31 March 2019 and has been professionally assessed by Neal Weekes of Gordon Brothers (RICS accredited) at £4,000 ex-situ and £24,000 in-situ. This included not only the normal range of ovens, fridges and freezers and furniture but also meat "smoking" equipment which due to their size and fittings may be difficult to remove.

Therefore, the ex-situ valuation has been used for the preparation of the Statement of Affairs.

2. Stock

Stock is reflected in the Company's records as £9,456 but has been shown at £1 on the Statement of Affairs. The position will be reviewed following liquidation as it is likely much of the food stock will have been used or was perishable and it is likely that some suppliers may rely on Retention of Title clauses which will be verified by the liquidator post appointment.

A wet stock-take has been completed and I can confirm that the perishable food stocks have been disposed of.

3. Uncalled Share Capital

Shares worth £25,320 have been issued but are not currently paid up. These relate to an employee share ownership plan co-owned by a corporate trustee and the plan will be reviewed by the Liquidator post appointment.

4. Cash at Bank

Cash held in the Company's bank account is £80,879 and will be transferred to the estate following liquidation.

5. Deposits

Deposits are recorded in the Company's management accounts at £80,740. However, the realisable value is included in the Statement of Affairs at £1 and the liquidator will review these upon appointment to establish if any sums are recoverable.

6. Preferential Creditors

The preferential claim totals £12,095 and is in respect of employees' holiday pay.

7. Trade and Expense Creditors

In accordance with the Company's books and records the liability due to unsecured trade and expense creditors, is £144,969.

8. Employees

The unsecured element of employee claims amounts to £21,777 and is in relation to redundancy and pay in lieu of Notice.

9. HM Revenue & Customs

The total liability due to HM Revenue & Customs ("HMRC") is estimated to be £77,503 which includes VAT and PAYE/NIC. This does not include VAT for May and June.

10. Directors' and Other Loans

The amount owed to a Director for personal investments into the Company is £120,000. A further £140,000 is owed to an associated company and both of these loans are unsecured.
