AND UPON hearing Ian Tucker of Counsel for the First Applicant, Eleanor Temple of Counsel for the Second Applicant and the Respondent not attending and not being represented but being served by email on her attorney, and accepting such email as service

AND UPON the Respondent having requested that an email timed at 11:32pm on 3 September 2023 be placed before the Court, and such email having been considered by the Court

IT IS ORDERED that:

(1) Pursuant to Section 108 of the Insolvency Act 1986 ("Act") and Rule 12.36(2) of the Insolvency Rules 2016 ("Rules") and with effect from the date of the Court's Order, the Respondent be removed from office as liquidator of the companies in members' voluntary liquidation listed in Schedule 1 attached hereto and the companies in creditors' voluntary liquidation listed in Schedule 2 attached hereto, and Stephen John Hunt (the "Successor Practitioner") the Second Applicant be appointed as liquidator of the companies listed in Schedules 1 and 2 attached hereto.

- (7) The Respondent (whether by herself, her agents, her employees or otherwise howsoever) must permit the Successor Practitioner and / or his employees or agents to attend during normal business hours the Respondent's business premises including at Kewans Limited, Suite 1, 3rd Floor, 18 Market Place, Romsey, Hampshire, SO51 8NA (the "Premises") on such other dates as the Successor Practitioner may reasonably require, so that the all of the documents and articles listed in Schedule 3 to the Order which are capable of being delivered up for collection in respect of the companies listed in Schedules 1 and 2 to the Order can be delivered up to the Successor Practitioner, including but not limited to:
 - a. Vision blue and/or IPS records;
 - b. time records;

- c. physical files and documents; and
- d. electronic case files.

- (12) Pursuant to Rules 18.24 and 18.28 and/or Rule 12.37(1)(e) in respect of each of the companies listed in Schedules 1 and 2, the Second Applicant's remuneration as liquidator of each company shall be increased, and to the extent necessary the basis changed so as to include a fixed fee, from any amount previously set, so as to include the additional sum of £10,000 plus VAT as a fixed fee (the "Fixed Fee").
- (13) The Fixed Fee shall, in each case, be treated for all purposes as having the priority set out at Rule 6.42(a) of the Rules.
- (14) The total to be drawn across the totality of the appointments effected by this order as Fixed Fees shall be no more £185,230 plus VAT.
- (15) The order at Paragraph 13 is:
 - a. in addition to any previous fee resolution and does not replace or rescind the same; and
