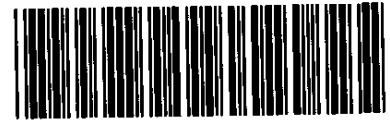

You cannot use this form to second filing of a document under the Companies Act 1985 the Companies (Northern Ireland) Order 1986 regardless of whether it was delivered.
