

Prescribed particulars	<p>Voting rights holders of Ordinary Shares are entitled to receive notice of and to attend, speak and vote at all general meetings of the Company. The holders of Ordinary Shares are entitled to one vote per share at any general meeting of the Company.</p> <p>Dividend rights holders of Ordinary Shares are entitled to a dividend in priority to the holders of A Ordinary Shares of such sum as is equal to 5% per annum of the amount subscribed for Ordinary Shares. If in any financial year some or all of this dividend is unpaid, the unpaid element accrues to this entitlement and further accrues at a rate of 5% per annum.</p> <p>Return of capital on a distribution of surplus assets and retained profits on a winding-up or other return of capital, the holders of the Ordinary Shares are entitled to receive (after a sum equal to £1 per share for each A Ordinary Share has been paid) a sum equal to £1 per share for each Ordinary Share and the amount of any accrued but unpaid dividend due to the holders of Ordinary Shares.</p> <p>Redemption the Ordinary Shares are not liable for redemption.</p>
