DIRECTORS' REPORT FOR THE YEAR ENDED 31 MAY 2016

The directors present their report and the unaudited financial statements for the year ended 31 May 2016

PRINCIPAL ACTIVITIES

Bristol Green Capital Partnership (BGCP) CIC is an independent organisation with a network of member organisations whose shared aim is to make Bristol a low carbon city with a high quality of life for all

The principal activities of the company during 2015/16 were supporting and promoting members' activities, creating collaborative spaces, providing thought-leadership and a voice to advocate for changes needed to achieve a more sustainable city. A key priority during 2015/16 was developing and transitioning to a more sustainable business model with the ability to support and influence positive change, allowing BGCP CIC to transition into an organisation that will build on and develop the work of Bristol 2015 Ltd following the city's year as European Green Capital

BACKGROUND

In 2014/15, the establishment of BGCP CIC marked the shift from a voluntary-led network to an independent organisation, with a number of important reviews of its activities, purpose and financial sustainability

In 2015/16, income from the grant from Bristol 2015 Ltd. continued to support the CIC's activities, allowing it to build leadership, development and operational capacity

This grant income during this period enabled BGCP CIC to both support directly and to help Partnership members to participate and be involved with events and activities throughout European Green Capital 2015, working closely with the Bristol 2015 Ltd delivery company

During this period, BGCP CIC also delivered an extensive programme of events to amplify the efforts of its members and to showcase Bristol's leadership on the future cities/sustainable cities agendas. The CIC also developed several collaborative projects and forums offering support to our member organisations - enabling new connections to be made and nurturing existing connection. Alongside delivering these activities, a key focus in 2015/16 was developing a new business model and associated new governance structures.

The 2015/16 financial year also saw a continuing increase in the membership of the Partnership's network, reaching over 800 organisations, all of which have 'taken the pledge', to "help make Bristol a low carbon city with a high quality of life for all"

DEVELOPMENT AND TRANSITION

In December 2015, the previous Board of Directors of and CIC members agreed a revision to the new articles of association, paving the way for the new business model and governance structure

A group of initial strategic partners (ISPs), representing anchor institutions and sustainability leaders in Bristol, became core funders of the CIC and company members. Each company member has senior representative as a director on the CIC's new Board, with the skills and experience necessary to ensure statutory requirements are fulfilled and bringing their leadership and expertise to guide BGCP CIC's ongoing development.

This new Board met for the first time in January 2016 and monthly thereafter

As required by the revised articles of association, and to maintain the involvement of the Partnership's member organisations in CIC decision-making, two additional Directors were elected from and by this wider membership in February 2016

Throughout 2015/16 the Board received, reviewed and discussed key decision-making papers, helping to progress the organisation's work throughout the year, including developing the new model as well as supporting flagship events and projects. They also provided significant in-kind contributions to support the core programme, to help develop new partnerships and projects, and to provide essential company support (including payroll and finance)

These developments included the laying of groundwork for the processes to appoint the organisation's first Chief Executive Officer and a new independent Chair of the Board of Directors. A new CEO was successfully recruited, starting in role at the end of this financial year, while a process to appoint a chair who would be independent of the ISPs was ongoing and was successfully concluded with an appointment in October 2016.

From the start of this accounting period until 4 February 2016, Liz Zeidler was Chair of the Board of Directors

From 5 February 2016 to the end of this accounting period (June 2016), Professor James Longhurst (Professor of Environmental Science and Assistant Vice Chancellor for Environment and Sustainability at University of the West of England, Bristol), acted as the interim Chair of the Board of Directors

BGCP CIC's work was managed, supported and delivered by two members of staff

- an independently contracted Development Director, and
- a full-time, employed Operations Manager

The Development Manager post ended in March 2016

ENGAGEMENT ACTIVITIES

In the 2015/16 period, 300 individuals from 222 organisations attended one or more Quarterly Partnership Gatherings. These regular events are an opportunity for members to showcase projects and workshop new ideas, share essential information and opportunities, collaborate and share expertise. Gatherings also provide a consultation mechanism to enable a cross-sectoral network of members to have a voice in important city sustainability-related strategies and plans as outlined below. They are also an important vehicle to enable and develop work on the Partnership's 5 themes, energy, food, nature, resources and transport.

A transport-themed gathering (September 2015) presented inspiring sustainable transport and active travel initiatives and invited attendees to participate in the 'Good Transport Plan for Bristol' consultation. An energy-themed gathering (February 2016) provided updates on energy activities in the city and a consultation exercise on Bristol's recently drafted Framework for Climate and Energy Security, also known as 'Our Resilient Future'. A resources and waste gathering (May 2016) invited individuals and organisations working in the waste, recycling or reuse field to identify the priorities and exchange ideas about how we can work collectively to deliver Bristol's aspirations to become a zero-waste city.

Additionally, BGCP CIC organised a hustings for the Bristol mayoral elections (April 2016) to seek candidates' views on how they would make Bristol a more sustainable city with a high quality of life for all. This sold-out event was hosted in partnership with a range of city organisations (Bristol Pound, Bristol Cycling Campaign, Friends of the Earth and Sustrans). Over 200 people attended with further questions submitted online including local organisations, city residents and BGCP members. BBC Radio Bristol presenter, Laura Rawlings, chaired the debate which was broadcast live on community radio station Ujima Radio.

In April 2016, BGCP CIC hosted a lunchtime talk by Jonathon Porritt in collaboration with UWE and Friends of the Earth Bristol. Entitled 'What does it cost? a focus on the environmental and sustainability remit of the EU', this event offered an opportunity to hear one of the leading thinkers on the environment talk about the role and influence of the European Union on environmental and sustainability policy and practice

All events were recorded and made available online to ensure the CICs activities were accessible to a broader audience. Informal networking events also continued in this period, with 11 Partnership-hosted 'Green Mingles', offering informal networking opportunities for existing members and potential new members.

ADVOCACY AND THOUGHT-LEADERSHIP

In this period, BGCP CIC continued to work with partners to showcase the city's successes and share learning, exchange knowledge and help to position Bristol at being at the forefront of global sustainable city practice

In July 2015, as part of the 9th International Fairtrade towns conference, the CIC hosted over 50 guests from Fairtrade Towns in 22 countries across the world, showcasing Bristol as the UK's most sustainable city and sharing the story of how the European Green Capital 2015 award was achieved. Inspired by Bristol's depth of collaboration and partnerships, 72% of attendees said that they would use the information they learnt at the conference to connect with local sustainability groups in towns and cities in their own countries.

The CIC collaborated with University of Bristol Cabot Institute and the Bristol Festival of Ideas to convene discussions with partners in government, civil society and industry on how to achieve a thriving, equitable and sustainable future for Bristol. These explored issues such as environmental uncertainty, resilience, youth, devolution, austerity, governance, partnership and economics. Findings from these events were shared publicly through a series of blogs and a public talk during Bristol's first ever Festival of the Future City in November 2016.

In December 2015, BGCP CIC formed part of the Bristol delegation at COP21 – hosting a workshop at the International Council for Local Environmental Initiatives cities pavilion to share the story of the Bristol Green Capital Partnership and highlight Bristol's leadership in cross-sectoral and collaborative partnerships that it represents

In addition to this, staff and directors of Bristol Green Capital Partnership undertook more than 30 speaking engagements during the year – sharing the story of Bristol's journey to becoming a sustainable city and its collaborative approach with local and national students and academics, visiting international delegations and at a range of summits and conferences

The CIC's website and digital communications continued to offer an important communication platform for information exchange and thought-leadership for the membership and wider public audiences – with over 30,000 users visiting the website in this period for a total of 44,178 sessions 65% of these users were new visitors, demonstrating the reach of new projects such as Healthy City Week and the Good Transport Plan and continued interest on both a local and global scale

DEVELOPMENT OF NEW PROJECTS

In 2015/16, BGCP CIC developed and delivered a series of flagship projects that aimed to enable cross-sector collaboration, engage diverse communities in the sustainability agenda, and support new initiatives that contribute towards the vision of a low carbon city with a high quality of life for all

In October 2015, the CIC delivered the inaugural Healthy City Week showcasing local sustainability and healthcare initiatives during Bristol's year as European Green Capital – aiming to inspire citizens of Bristol to achieve 'well-being that doesn't cost the earth'. The week was developed in collaboration with the Partnerships health and well-being group and created through an open submission process. Across 10 days there were over 100 free events with over 3,000 attendances – a concentration of health and well-being events included seminars, talks, taster sessions and workshops. The CIC additionally curated a forum on deepening the links between the healthcare and sustainability sectors – convening a discussion with local healthcare and sustainability leaders and David Pencheon, Director of the NHS Sustainable Development Unit, followed by a free public talk.

99 local groups and organisations participated in the week and the social media hashtag #HealthyBristol was used over 2,000 times by over 550 Twitter user accounts in a fortnight alone, reaching potentially over 2 million accounts 69% of attendees who provided feedback stated that their experience had inspired them to change behaviour in their personal or professional life. This was all made possible through significant in-kind time and energy from many members of the partnership, and supported by financial sponsorship from Bristol Health Partners.

The event's positive feedback led the CIC to bring together over 50 of participants in the 2016 events in March 2016, along with new representatives from the healthcare and sustainability communities, to workshop ideas for Healthy City Week 2016 which took place in October 2016

In January 2016, BGCP CIC worked with company member Sustrans and a group of member organisations to launch 'A Good Transport Plan for Bristol'. The plan was produced by Sustrans on behalf of the Bristol Green Capital Partnership Transport Action Group. It aims to create change by setting out objectives and proposals that would make travelling into and around Bristol more sustainable, accessible and enjoyable. It is intended to inspire people in the city to see the potential for improving city transport. To help member organisations and other interested parties provide their own ideas, as part of the launch event, over 110 attendees fed into the West of England region's Joint Spatial Plan and Transport Study consultations as part of an early stage formal consultation.

The CIC also partnered with Crowdfunder UK in this period to launch the 'Better Bristol' crowdfunding campaign, intended to support and promote the activities of our member organisations as well as all those in the city with a passion for positive change. Over 120 hours of coaching was provided to community groups, businesses and innovative individuals, including 3 workshops hosted in Bristol. In this period over £175,000 was raised for 23 new and ongoing initiatives that contribute a happier and healthier Bristol. Additionally, more than 30 more organisations were equipped with skills and knowledge to develop their future crowdfunding campaigns.

DIVERSITY AND INCLUSION

Bristol is recognised for its leadership on environmental sustainability. However, there is a strong need to address issues of exclusion of certain groups, including Black and Minority Ethnic communities. In November 2015 and December 2016, BGCP CIC worked with community radio station Ujima Radio CIC, the University of Bristol's Cabot Institute and Public Engagement teams to run two 'Green and Black' community consultations on this issue. These followed on from Ujima Radio's initiative to involve Black And Minority Ethnic (BAME) communities in the Green agenda during Bristol European Green Capital 2015.

The report from these consultations highlighted the need for a different mix of leaders and voices, a continuous stream of positive project activity and a new narrative about meaning and engagement. The report specifically highlighted a need to invest in the leadership skills of those interested in bringing environmental and social justice in Bristol.

Taking forward these findings, the CIC continues to work with its partners Ujima Radio and the Cabot Institute to develop a new engagement and leadership programme with BAME communities – The Green and Black Ambassadors initiative – which began in 2016/17

FUTURE BGCP CIC DEVELOPMENT

We will continue to work inclusively and collaboratively with public, private, and community and voluntary sector organisations across the Bristol city-region to realise the change needed to address the environmental sustainability challenges we face. By enabling, delivering and leading we will achieve more than we can alone, and achieve our vision of a sustainable city-region with a high quality of life for all of its people. By doing this, we will continue to provide a model of partnership-working for sustainability for others, nationally and globally

1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015)

12 Going concern

The directors report that, after making enquires, they have concluded that the company will continue in operation for the foreseeable future. Therefore they will continue to adopt the going concern basis of accounting in preparing these financial statements.

It should be noted that the aim of Bristol Green Capital Partnership is to be not-for-profit, and that it is an organisation where regular grants are received from strategic partners to fund activities. The strategic partners are represented through their directorships in the company. The company is therefore reliant upon the support of its directors, who have given their assurance that they will continue to support the company. The financial statements have therefore been prepared on the going concern basis.

1.3 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases.

1.4 Grant income

Grants relating to tangible fixed assets are treated as deferred income and released to the profit and loss account over the expected useful lives of the assets concerned. Other grants are credited to the profit and loss account as the related expenditure is incurred.

The company is a not-for-profit organisation and in the opinion of the board of directors the company's activities do not constitute that of a trade. Consequently the directors consider that no corporation tax liability arises other than in respect of investment income.

In 2015/16, income from the grant from Bristol 2015 Ltd continued to support the CIC's activities, allowing it to build leadership, development and operational capacity

This grant income during this period enabled BGCP CIC to both support directly and to help Partnership members to participate and be involved with events and activities throughout European Green Capital 2015, working closely with the Bristol 2015 Ltd delivery company

During this period, BGCP CIC also delivered an extensive programme of events to amplify the efforts of its members and to showcase Bristol's leadership on the future cities/sustainable cities agendas. The CIC also developed several collaborative projects and forums offering support to our member organisations - enabling new connections to be made and nurturing existing connection. Alongside delivering these activities, a key focus in 2015/16 was developing a new business model and associated new governance structures.

The 2015/16 financial year also saw a continuing increase in the membership of the Partnership's network, reaching over 800 organisations, all of which have 'taken the pledge', to "help make Bristol a low carbon city with a high quality of life for all"

DEVELOPMENT AND TRANSITION

In December 2015, the previous Board of Directors of and CIC members agreed a revision to the new articles of association, paving the way for the new business model and governance structure

A group of initial strategic partners (ISPs), representing anchor institutions and sustainability leaders in Bristol, became core funders of the CIC and company members. Each company member has senior representative as a director on the CIC's new Board, with the skills and experience necessary to ensure statutory requirements are fulfilled and bringing their leadership and expertise to guide BGCP CIC's ongoing development.

This new Board met for the first time in January 2016 and monthly thereafter. As required by the revised articles of association, and to maintain the involvement of the Partnership's member organisations in CIC decision-making, two additional Directors were elected from and by this wider membership in February 2016.

Throughout 2015/16 the Board received, reviewed and discussed key decision-making papers, helping to progress the organisation's work throughout the year, including developing the new model as well as supporting flagship events and projects. They also provided significant in-kind contributions to support the core programme, to help develop new partnerships and projects, and to provide essential company support (including payroll and finance)

These developments included the laying of groundwork for the processes to appoint the organisation's first Chief Executive Officer and a new independent Chair of the Board of Directors. A new CEO was successfully recruited, starting in role at the end of this financial year, while a process to appoint a chair who would be independent of the ISPs was ongoing and was successfully concluded with an appointment in October 2016.

From the start of this accounting period until 4 February 2016, Liz Zeidler was Chair of the Board of Directors

From 5 February 2016 to the end of this accounting period (June 2016), Professor James Longhurst (Professor of Environmental Science and Assistant Vice Chancellor for Environment and Sustainability at University of the West of England, Bristol), acted as the interim Chair of the Board of Directors

BGCP CIC's work was managed, supported and delivered by two members of staff

- an independently contracted Development Director, and
- a full-time, employed Operations Manager

ENGAGEMENT ACTIVITIES

In the 2015/16 period, 300 individuals from 222 organisations attended one or more Quarterly Partnership Gatherings. These regular events are an opportunity for members to showcase projects and workshop new ideas, share essential information and opportunities, collaborate and share expertise. Gatherings also provide a consultation mechanism to enable a cross-sectoral network of members to have a voice in important city sustainability-related strategies and plans as outlined below. They are also an important vehicle to enable and develop work on the Partnership's 5 themes, energy, food, nature, resources and transport.

A transport-themed gathering (September 2015) presented inspiring sustainable transport and active travel initiatives and invited attendees to participate in the 'Good Transport Plan for Bristol' consultation. An energy-themed gathering (February 2016) provided updates on energy activities in the city and a consultation exercise on Bristol's recently drafted Framework for Climate and Energy Security, also known as 'Our Resilient Future'. A resources and waste gathering (May 2016) invited individuals and organisations working in the waste, recycling or reuse field to identify the priorities and exchange ideas about how we can work collectively to deliver Bristol's aspirations to become a zero-waste city

Additionally, BGCP CIC organised a hustings for the Bristol mayoral elections (April 2016) to seek candidates' views on how they would make Bristol a more sustainable city with a high quality of life for all. This sold-out event was hosted in partnership with a range of city organisations (Bristol Pound, Bristol Cycling Campaign, Friends of the Earth and Sustrans)

Over 200 people attended with further questions submitted online including local organisations, city residents and BGCP members. BBC Radio Bristol presenter, Laura Rawlings, chaired the debate which was broadcast live on community radio station Ujima Radio.

In April 2016, BGCP CIC hosted a lunchtime talk by Jonathon Porritt in collaboration with UWE and Friends of the Earth Bristol Entitled 'What does it cost? a focus on the environmental and sustainability remit of the EU', this event offered an opportunity to hear one of the leading thinkers on the environment talk about the role and influence of the European Union on environmental and sustainability policy and practice

All events were recorded and made available online to ensure the CICs activities were accessible to a broader audience. Informal networking events also continued in this period, with 11 Partnership-hosted 'Green Mingles', offering informal networking opportunities for existing members and potential new members.

ADVOCACY AND THOUGHT-LEADERSHIP

In this period, BGCP CIC continued to work with partners to showcase the city's successes and share learning, exchange knowledge and help to position Bristol at being at the forefront of global sustainable city practice

In July 2015, as part of the 9th International Fairtrade towns conference, the CIC hosted over 50 guests from Fairtrade Towns in 22 countries across the world, showcasing Bristol as the UK's most sustainable city and sharing the story of how the European Green Capital 2015 award was achieved. Inspired by Bristol's depth of collaboration and partnerships, 72% of attendees said that they would use the information they learnt at the conference to connect with local sustainability groups in towns and cities in their own countries.

The CIC collaborated with University of Bristol Cabot Institute and the Bristol Festival of Ideas to convene discussions with partners in government, civil society and industry on how to achieve a thriving, equitable and sustainable future for Bristol. These explored issues such as environmental uncertainty, resilience, youth, devolution, austerity, governance, partnership and economics. Findings from these events were shared publicly through a series of blogs and a public talk during Bristol's first ever Festival of the Future City in November 2016.

In December 2015, BGCP CIC formed part of the Bristol delegation at COP21 – hosting a workshop at the International Council for Local Environmental Initiatives cities pavilion to share the story of the Bristol Green Capital Partnership and highlight Bristol's leadership in cross-sectoral and collaborative partnerships that it represents

In addition to this, staff and directors of Bristol Green Capital Partnership undertook more than 30 speaking engagements during the year – sharing the story of Bristol's journey to becoming a sustainable city and its collaborative approach with local and national students and academics, visiting international delegations and at a range of summits and conferences

The CIC's website and digital communications continued to offer an important communication platform for information exchange and thought-leadership for the membership and wider public audiences — with over 30,000 users visiting the website in this period for a total of 44,178 sessions 65% of these users were new visitors, demonstrating the reach of new projects such as Healthy City Week and the Good Transport Plan and continued interest on both a local and global scale

DEVELOPMENT OF NEW PROJECTS

In 2015/16, BGCP CIC developed and delivered a series of flagship projects that aimed to enable cross-sector collaboration, engage diverse communities in the sustainability agenda, and support new initiatives that contribute towards the vision of a low carbon city with a high quality of life for all

In October 2015, the CIC delivered the inaugural Healthy City Week showcasing local sustainability and healthcare initiatives during Bristol's year as European Green Capital — aiming to inspire citizens of Bristol to achieve 'wellbeing that doesn't cost the earth' The week was developed in collaboration with the Partnerships health and wellbeing group and created through an open submission process. Across 10 days there were over 100 free events with over 3,000 attendances — a concentration of health and wellbeing events included seminars, talks, taster sessions and workshops. The CIC additionally curated a forum on deepening the links between the healthcare and sustainability sectors — convening a discussion with local healthcare and sustainability leaders and David Pencheon, Director of the NHS Sustainable Development Unit, followed by a free public talk

99 local groups and organisations participated in the week and the social media hashtag #HealthyBristol was used over 2,000 times by over 550 Twitter user accounts in a fortnight alone, reaching potentially over 2 million accounts 69% of attendees who provided feedback stated that their experience had inspired them to change behaviour in their personal or professional life. This was all made possible through significant in-kind time and energy from many members of the partnership, and supported by financial sponsorship from Bristol Health Partners.

The event's positive feedback led the CIC to bring together over 50 of participants in the 2016 events in March 2016, along with new representatives from the healthcare and sustainability communities, to workshop ideas for Healthy City Week 2016 which took place in October 2016

In January 2016, BGCP CIC worked with company member Sustrans and a group of member organisations to launch 'A Good Transport Plan for Bristol'. The plan was produced by Sustrans on behalf of the Bristol Green Capital Partnership Transport Action Group. It aims to create change by setting out objectives and proposals that would make travelling into and around Bristol more sustainable, accessible and enjoyable. It is intended to inspire people in the city to see the potential for improving city transport. To help member organisations and other interested parties provide their own ideas, as part of the launch event, over 110 attendees fed into the West of England region's Joint Spatial Plan and Transport Study consultations as part of an early stage formal consultation.

The CIC also partnered with Crowdfunder UK in this period to launch the 'Better Bristol' crowdfunding campaign, intended to support and promote the activities of our member organisations as well as all those in the city with a passion for positive change. Over 120 hours of coaching was provided to community groups, businesses and innovative individuals, including 3 workshops hosted in Bristol. In this period over £175,000 was raised for 23 new and ongoing initiatives that contribute a happier and healthier Bristol. Additionally, more than 30 more organisations were equipped with skills and knowledge to develop their future crowdfunding campaigns.

DIVERSITY AND INCLUSION

Bristol is recognised for its leadership on environmental sustainability. However, there is a strong need to address issues of exclusion of certain groups, including Black and Minority Ethnic communities. In November 2015 and December 2016, BGCP CIC worked with community radio station. Ujima Radio CIC, the University of Bristol's Cabot Institute and Public Engagement teams to run two 'Green and Black' community consultations on this issue. These followed on from Ujima Radio's initiative to involve Black And Minority Ethnic (BAME) communities in the Green agenda during Bristol European Green Capital 2015.

Taking forward these findings, the CIC continues to work with its partners Ujima Radio and the Cabot Institute to develop a new engagement and leadership programme with BAME communities – The Green and Black Ambassadors initiative – which began in 2016/17

We will continue to work inclusively and collaboratively with public, private, and community and voluntary sector organisations across the Bristol city-region to realise the change needed to address the environmental sustainability challenges we face. By enabling, delivering and leading we will achieve more than we can alone, and achieve our vision of a sustainable city-region with a high quality of life for all of its people. By doing this, we will continue to provide a model of partnership-working for sustainability for others, nationally and globally
