AND UPON THE COURT being satisfied that it is expedient to transfer all the cases listed in Schedule A (Part 2) (annexed to this order) to the Third Respondent in one single order

IT IS ORDERED THAT:-

- 1. Permission is granted to amend the application notice to delete the second to fourth named applicants as applicants.
- 2. The Outgoing Office-holder be removed from office in respect of each of the Block Transfer Cases listed in Schedule A from the date of this order.
- 3. Steven Illes be appointed as the replacement office-holder in respect of each of the Block
 Transfer Cases listed in Part 1 of Schedule A from the date of this order.
- 4. Michael Colin John Sanders be appointed as the replacement office-holder in respect of each of the Block Transfer Cases listed in Part 2 of Schedule A from the date of this order.
- 5. The creditors in each of the Block Transfer Cases be notified of this order either by letter or by advertisement published in the London Gazette within 3 months of this order and the Applicant is required to advertise the transfer of the Block Transfer Cases in any event within 3 months.
