ORDER

UPON THE APPLICATION of the Applicant dated 24 June 2022

AND UPON READING the evidence

IT IS ORDERED:

1. The Applicant, Rachel Louise Ballinger ('Outgoing Officeholder') be removed from office in respect of each of the cases listed in Schedules A, B and C (attached to this order) ('Block Transfer Cases') from the date of this order.

2. The Respondent, Brett Lee Barton, be appointed as replacement liquidator in respect of each of the cases listed in Schedule A.
3. The Respondent, remain sole liquidator in respect of each of the cases listed in Schedules B and C.
4. The creditors in each of the Block Transfer Cases be notified of this order by one advertisement in the London Gazette relating to the Block Transfer Cases, within 14 days of the Outgoing Officeholder's solicitors receiving a sealed order of this order. The creditors shall also be notified of the removal of the Outgoing Officeholder within the next progress report.
5. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the Block Transfer Cases, who has an objection to this order shall have 28 days from the date of the advertisement in the London Gazette, to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases, until further or other order by the court.
6. The Respondent shall give notice to the Secretary of State, the Registrar of Companies in respect of the Block Transfer Cases, of the terms of this order as soon as reasonably practicable.
7. The Outgoing Officeholder shall receive her release as office holder of the Block Transfer Cases, 28 days after the giving of notice to creditors in accordance with this order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 3 of this order for the specific case subject to that application.
8. The costs of this application shall be paid as an expense of and by BLB Advisory Limited.
