In our fifth year Friends of Spud Wood CIC (FoSW) has continued to undertake a range of activities with a large focus on running the wood allotment scheme. The contract was renewed in September 2018 for a further 3 years.

This year we have operated 23 allotments, we can have a maximum of 25. We have continued working with the site manager – Neil Oxley – to ensure that the allotments owners have been active and safe when felling in their allotments. Andy Cooper, our chainsawer, has continued to support us both in the wood allotments and in the coppicing work we have been doing. The total number of active members of the wood allotment scheme was 33.

In addition to the wood allotments we have also been caring for the trees planted in 2014, planting some new ones in March 2019 with the help of year 4 at Oughtrington Primary School, coppicing, hedge laying, setting up an orienteering course, holding a family orienteering event during Lymm Festival and running a variety of ecology field trips for Ravenbank Primary School and Lymm High School.

The FoSW volunteers were helped and supported by Lymm Round Table, Bridgewater Canal Company, 3rd Lymm Scouts who assisted with the orienteering course set-up and by Sale and Altrincham Conservation Volunteers who attended coppicing events.

In our fifth year we have been supporting The Woodland Trust by showing visitors around the wood, undertaking woodland management through the wood allotment scheme, hedgelaying and holding several coppicing days on site, setting up an orienteering course and running a linked activity day, holding some ecology field trips with local schools and planting trees.

We had our AGM on 26th September 2018 and advertised it on our website and with posters in Spud Wood.
