IT IS ORDERED THAT:

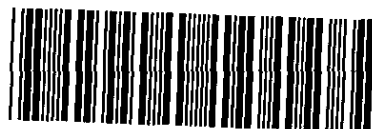
1. The name of 1. B.E.T SOCIAL WORK SOLUTIONS LTD (registration number 09186045) be restored to the Register of Companies
