  new legal entity is now appropriate to hold a long term lease of the building from
  Shropshire Council. The assets of the former Bog Volunteer Group were transferred to
  the new C.I.C. giving the company the resources to trade and to begin maintenance
  work on the building.
- The terms of the new 25 year lease were agreed between The Bog and Shropshire Council.
- A maintenance plan was devised, priorities agreed for work in 2017 and contractors found
- Training of the former volunteers (now members) was carried out to ensure standards
  of food hygiene, health and safety, customer care etcetera are high. This enhances
  the skill level of local people.

  - There is ongoing and regular consultation with our stakeholders which leads to joint events.
  - Specific consultation with Natural England resulted in a joint event 'The Hay Festival', held in June, which encouraged the public to learn about conservation of this unique area.
  - Consultation with The Stiperstones and Corndon Partnership has created a funding opportunity.
  - Several group talks and guided walks to the remains of the local mines and the Somme Tunnel were given, in consultation with The Mines Trust.
  - The Twentieth Anniversary of the opening of The Bog Visitor Centre was a celebration for the Stiperstones Community including many local founder members.
  - Two large cycle events (over 300 cyclists at one time) were held as a result of consultation with local cycling clubs.
  - A vintage car rally was held following consultation with a club.
