1. STATUTORY INFORMATION

Event Spaces Limited is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

The presentation currency of the financial statements is the Pound Sterling (£).

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The accounts have been prepared on the going concern basis as the directors are of the opinion that the company will meet its liabilities as and when due, due to the continued support of the directors.

Short term debtors and creditors

Short term debtors and creditors with no stated interest rate are recorded at transaction price. Any losses arising from impairment are recognised in the profit and loss account.

3. EMPLOYEES AND DIRECTORS

The average number of employees during the year was NIL (2021 - NIL).

4. RELATED PARTY DISCLOSURES

At the balance sheet date, the company owed £122,500 (2021: £187,500) to Ingenious Entertainment VCT 1 PLC, a company which owns 50% of the A Ordinary shares.

At the balance sheet date, the company owed £122,500 (2021: £187,500) to Ingenious Entertainment VCT 2 PLC, a company which owns 50% of the A Ordinary shares.

During the year ended 2020, significant losses totalling £1,278,685, were made as a result of an exhibition named "Art of the Brick".

The company was successful in pursuing legal action in order to recover this sum under an indemnity given by a shareholder, under the terms of the relevant Investment Agreement.

That shareholder entered an Individual Voluntary Arrangement to reduce the amount due back to the Company, but continues to make regular payments in line with expectations.
