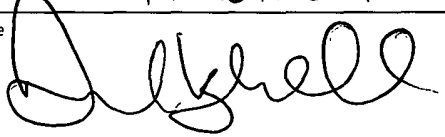

1. The first part of the document is a letter from the President of the United States to the Congress, dated January 1, 1801. 3. The third part of the document is a report from the Secretary of the Navy, dated January 1, 1801. It provides a detailed account of the state of the Navy at the time. The report discusses the fleet, the personnel, and the various operations that have been carried out. It also includes a table showing the various ships in the fleet and their specifications. The Secretary concludes by stating that the Navy is committed to maintaining a strong and effective fleet and to ensuring the security of the nation's maritime interests.
