1 Accounting policies

Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with FRS 102, The Financial Reporting Standard applicable in the UK and Republic of Ireland (as applied to small entities by section 1A of the standard).

Turnover

Turnover is measured at the fair value of the consideration received or receivable, net of discounts and value added taxes. Turnover includes revenue earned from the sale of goods and from the rendering of services. Turnover from the sale of goods is recognised when the significant risks and rewards of ownership of the goods have transferred to the buyer. Turnover from the rendering of services is recognised by reference to the stage of completion of the contract. The stage of completion of a contract is measured by comparing the costs incurred for work performed to date to the total estimated contract costs.

Tangible fixed assets

Tangible fixed assets are measured at cost less accumulative depreciation and any accumulative impairment losses. Depreciation is provided on all tangible fixed assets, other than freehold land, at rates calculated to write off the cost, less estimated residual value, of each asset evenly over its expected useful life, as follows:

Plant and machinery 30% reducing balance Motor vehicles 25% reducing balance

Debtors

Short term debtors are measured at transaction price (which is usually the invoice price), less any impairment losses for bad and doubtful debts. Loans and other financial assets are initially recognised at transaction price including any transaction costs and subsequently measured at amortised cost determined using the effective interest method, less any impairment losses for bad and doubtful debts.

Creditors

Short term creditors are measured at transaction price (which is usually the invoice price). Loans and other financial liabilities are initially recognised at transaction price net of any transaction costs and subsequently measured at amortised cost determined using the effective interest method.

Taxation

A current tax liability is recognised for the tax payable on the taxable profit of the current and past periods. A current tax asset is recognised in respect of a tax loss that can be carried back to recover tax paid in a previous period. Deferred tax is recognised in respect of all timing differences between the recognition of income and expenses in the financial statements and their inclusion in tax assessments. Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits. Deferred tax is measured using the tax rates and laws that have been enacted or substantively enacted by the reporting date and that are expected to apply to the reversal of the timing difference, except for revalued land and investment property where the tax rate that applies to the sale of the asset is used. Current and deferred tax assets and liabilities are not discounted.

Case Study – Qualitative Impact Jordon in September 2016 was struggling in a school environment and was in danger of disengaging in education altogether.

Jordon's attendance was slipping and through his frustration Jordon was getting into a lot of fights. Over the course of the year with Loadeduk Jordon's attendance was 100% and he only missed one day due to illness. We saw Jordon begin to eat healthily, manage his behaviour and grow in a number of skills in the outdoors. Jordon said, "I use to fight a lot, a lot! Now that has changed because I have learnt to control my temper. I now know when I need to get up and walk out and have 5 minutes"

"I used to struggle to finish things and now I have completed something, since coming here I've grown so much, this has been one of the best times of my life" Jordon has now completed a B-TEC level 2 in PSD, a B-TEC in Construction and finished his Duke of Edinburgh Bronze. Jordon has been accepted into College Sir Gar in Construction he starts this September 2017 and he is excited.

The feedback from Thomas has been positive throughout and he thoroughly enjoys the structure and activities organised by your experienced team in Llanelli.

The parents have also been fully supportive of Thomas' alternative curriculum and have seen a remarkable change in his behaviour and attitude at home - his younger sibling, who is a pupil in year 9, has also flourished as he isn't unduly influenced by Thomas within the school setting.

We also appreciate your communication with the school, and the fact that both school and yourself have been consistent with both Thomas and parents with regard to expectations and behaviour.
